# MoPTA WORLD CAFÉ UPDATE

Three MoPTA World Cafés will be used to gather information and consider changes to the MoPTA for 2016-2017.

MoPTA Café #1 – The first MoPTA Café will be held in Jefferson City on Wednesday, February 23, 2016. A selected number of 2015 MoPTA candidates and faculty have been invited to participate. Invitations were sent last week to 50 candidates and 20 faculty members. The goal is to have a minimum of 35 candidates and 14 faculty members respond to a specific series of questions. The information will be gathered and reported out on Friday, January 29. The roundtable discussions will occur in the morning. A series of activities have been planned for the afternoon. Invitations were sent to cross-section of candidates and faculty members.

Electronic MoPTA Café #2 – The Electronic World Café will be held in early to mid-February. Candidates and faculty members from across the state will have an opportunity to respond to the similar questions. The information will be gathered and reported on February 26. An electronic World Café was used to gather information about MoSPE several years ago.

MoPTA Café #3 @ the MACTE Spring Conference – The Office of Educator Quality will be working with the MACTE Spring Conference Committee to host the third MoPTA Café. The MACTE Spring Conference is scheduled for late March.

Report to ETS – The information gathered from all of the events will be reported on April 15 and shared with ETS. Any changes to the MoPTA for 2016-2017 will be posted on or before July 1.
