

Update from the CGEIP Chair on the Application and Review Process for the revision of the general education curriculum is as follows:

CGEIP met in March/early April (March 6th, March 20th, March 27th, & April 3rd) to review courses submitted by March 1, 2013. The following is a summary of the activities of CGEIP as of April 3rd:

CGEIP had a total of 59 applications to review for the regular March 6th CGEIP and Special March 20th CGEIP meetings (carryover meetings of the March 20th meeting occurred on March 27th and April 3rd). In the April 3rd meeting all courses that have been submitted to CGEIP had reviews completed and the Revised General Education Program was approved by CGEIP to send to Faculty Senate. All the applications with syllabi for courses approved and denied by CGEIP will go to faculty senate with the Revised General Education Program for Faculty Senate to review in April. Below is a summary of the CGEIP review process of course applications for entrance into the Revised General Education:

I. **147 Applications** for entrance into the Revised General Education submitted by **March 1st**

A) **96 Applications Approved**

- **57% Approval rate on 1st submission** (41 resubmissions approved on 2nd submission)

B) **50 Applications Denied**

- **41 Applications** denied then resubmitted and **approved in second submission**
- **7 Applications NOT approved** by CGEIP even on resubmission
 - **5 Applications denied and no resubmission** by March 1st
 - **2 Application denied on 2nd submission** (*AST112 & NUR442*)
- **2 Applications NOT approved in one area but approved in other** area of the revised general education (*ECO165 & PHI105*)

II. **103 Courses Reviewed**

A) **96 Accepted** into the Revised General Education Program

- **94 Courses** sent forward in Revised General Education Program
- **2 Courses NOT** sent forward waiting on Approval of New Course Forms (*ENG287 & MTH121*)

B) **7 Denied** into the Revised General Education Program

- *AST112, ENG200, IDS297, IDS 397, MUS345, MUS346, NUR442*

III. 6 Current General Education Courses not submit for Revised General Education (*CHM160/161, CSC111, GST170, ENG296, PSY101, and THE101*)
