- Revising Bylaw: Under Article VIII: Subsection V Motion Passes
  - o NOW: "Invoices for IFC chapter dues will be sent out six weeks following the submission of finalized rosters and will be due two weeks after the invoices are sent out. Dues will be \$15 per active member for chapters and \$8 per active member for colonies."
  - o PRESENTING: "Invoices for IFC chapter dues will be sent out six weeks following the submission of finalized rosters and will be due two weeks after the invoices are sent out. Dues will be \$12 per initiated member for chapters and \$8 per initiated member for colonies."

## XI. New Business

Resolution Bill

BE IT ENACTED BY THE INTER FRATERNITY COUNCIL HERE ASSEMBLED THAT:

SECTION 1. IFC has determined the official recruitment period run from August 20th to August 23<sup>rd</sup>, and that a "no-bid period" be enacted beginning August 24th and ending August 31st.

**SECTION 2.** "No-bid period" is defined as a time in which no bids should be distributed in any capacity.

**SECTION 3.** The Inter-Fraternity Council Vice President of Recruitment will oversee this policy.

A. The Inter-Fraternity Council Vice President of Recruitment must make sure that bids are readily available as soon as the recruitment period begins.

SECTION 4. If passed, the dates reflected on this bill will be scheduled immediately.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
