Article VII: Meeting

A chapter whose representatives have over two unexcused absences per representative will lose voting VI. rights for the remainder of the semester.

Proposal:

VI. Attendance:

- a. Chapters with an unexcused absence will lose voting rights for the following General Council meeting.
- b. Chapters with more than two unexcused absences in the same semester will go through the IFC Standards Board process.
- Chapters with perfect attendance for a full semester will receive a 5% dues reduction for the following c. semester.
