

- Department of Elementary and Secondary Education (DESE) Teacher Standards
- Comprehensive Exam during SFR 781 (pass rate, incomplete grades)
- MEES during SEC 783 (practicum) and SEC 784 (student teaching)

ASSESSING PROCESS WITH EVIDENCE – OUR TO-DO LIST

Admission - GradCAS and Grad Dashboard Admission Systems

- All the documentation for admitting and advising students need to be in one place for the Program Director and Advisors to retrieve.
- Remove unnecessary requirements that may create barriers
- Update and review website for consistency of current guidelines and regulations

Recruitment and Retention (Advising checkpoints)

- add an accelerated master's to the MAT program
- promote the registered Apprenticeship program (US Department of Labor and MoJobs)
- ensure student's Program of Study is on track and they know how to run a degree audit.
- students know who to contact and where to find information to stay informed

DESE Teacher Standards

- Review standard alignment
- Check for overlap and gaps
- MEES (Missouri Educator Evaluation System)—curriculum alignment and pass rate

Comprehensive Exam

The comprehensive exam is in the form of a presentation of action research. Is this presentation an effective way to help us determine *student's understanding of how to properly*

- investigate a problem and suggest solutions based on research studies and/or
- conduct a research study to improve practice



Items Chosen for Action

DATA TO BE COLLECTED AND STRATEGIES TO IMPLEMENT

- MAT Advisory Committee meeting held annually to receive input from program faculty, school district personnel, and university supervisors.
- Exit survey from MAT graduating students.
- Revisit the comprehensive exam presentation format.
- Verify alignment to standards and the MEES requirements and avoid overlapping content in different courses.
- Promote the Apprenticeship Program to MAT students. Analyze participation rate and funding amounts.
- Participation rate and retention rate for Accelerated Master's





Follow-up Plans & Next Steps

- Create an evaluation checklist for ongoing outcome assessments.
- Apply for Assessment Grant to host Program Advisory Committee meetings.
- Meet with program faculty and supervisors to evaluate the learning outcomes assessment methods for each course and for the MEES.
- Develop a recruitment and retention plan with input from the advisory committee.
- Promote the Accelerated Master's and Apprenticeships programs.
- Consider designing a mentorship program.

- Assessment Office Funding for Program Advisory Meeting
- College Dean's Office Funding for attending recruiting event(s)
- College Dean's Office Funding for purchasing recruiting materials
- US Department of Labor—Apprenticeship applications and regulations.
