SEC 4 Membership of the Educator Preparation Provider Council A.

CURRENT MEMBERSHIP DEFINITION

An EPPC member who represents the faculty must be a member of the EPP. Faculty/staff who teach one or more EPP courses, advise or supervise educator preparation students, or administer educator preparation academic departments/units* or colleges must be members of the EPP.

SUGGESTED CHANGES TO CURRENT MEMBERSHIP DEFINITION

An EPPC member who represents the faculty must be a member of the EPP. **Full- or part-time faculty/staff** who teach one or more EPP **professional education** courses, **advise or supervise educator preparation students, or administer educator preparation academic departments/units* or colleges** must be members of the EPP.

Dear Program Coordinators –

In line with the EPP Membership bylaw change proposal that passed @ EPPC this month (see attachment) and the discussion regarding the need for definition clarity of EPP professional education courses, for consistency within Secondary, ***please consider all faculty (full-time and part-time) who teach any courses within Sections A & B of your program's DESE matrix as needing membership within the EPP.*** It will also be this list of EPP Membership faculty who will be included in any Digital Measures reports run for PK-12 experiences.

We request your assistance with the following:

- 1) Please check the EPP Membership attachment: Let Vicki know any name changes (additions or deletions) that need to be made for your specific program to align with the criteria provided above ***by Fri., Nov. 3.***
- 2) Please send the EPP Membership Application form to the 'new' faculty additions for EPP membership as soon as possible and please request if they would complete the form by ***Nov. 30.*** Let them know that they may need to print and scan the document to send it for the appropriate signatures. Also, let them know that in the paragraph describing their PK-12 involvement, including past experiences is appropriate; however, they must include ***current, periodic*** involvement in PK-12.

Once the faculty are officially accepted into the EPP, James will send them an email on how to access Digital Measures, and work with them if needed, so they may successfully complete the Digital Measures process.
