III. Rationale (required)

Assessment of Student Learning Outcomes Associate with the Public Affairs Mission

Missouri State University selected assessment of student learning in public affairs as the focus of its Quality Initiative Proposal (QIP). Through this project a variety of significant outcomes have been accomplished including hiring a Director of Assessment, developing a process for assessing artifacts from select courses, aligning institutional outcomes with general education, public affairs, student affairs and professional education outcomes, developing a Public Affairs Toolkit for instructors, changing the University Exit Exam, implementing curricular changes, and developing a Public Affairs Assessment Grant program. These numerous projects represent significant effort and broad participation by students and staff from all colleges and schools. The University's comprehensive QIP Report clearly mapped progress for each of its 2012 program goals and provided evidence of the scope and impact of this important project. The institution committed significant monetary and personnel resources to the QIP and responded to suggestions from proposal reviewers in a way which strengthened their efforts. Missouri State University is to be commended for its work on this three-year project which has the potential to impact other institutions through the sharing of resources as outlined in the report.
