The committee reviewed the draft report for Criterion 1. Discussion followed with information provided that will be reviewed and added to the report.

Make sure this speaks to the full mission statement not just public affairs.

- 1A Where and how do we include Sheely Farm and the Woodlands and IDEA Commons?
- 1A1 Add the new Center for Community Engagement which shows a recent development.
- 1A1 Signature events and other events list the date of the start of each to show evolution of the mission. Need to name the awards. We either need to leave out Missouri Campus Compact or use words to describe it more fully.
- 1A1 Last paragraph add "and every academic program as required by Faculty Senate action dated _____"
- 1A2 Need to provide enrollment profile to show that it is consistent with the mission. There is data in marketing study and senior survey (Keri?) that support last sentence of first paragraph.
- 1A2 Quality Initiative Project (QIP) active not was
- 1A2 Need to includes dates and timelines for everything!

- 1A2 Paragraph leading into bulleted list on page 6 must include not just students but faculty, staff, and administration. It needs to include academic affairs, student affairs and HR in order to be inclusive of the examples provided.
- 1A3 Need timelines of the budget process. Need to not just say "documents are posted" but need to name the documents!
- 1A3 Last sentence "One Key Performance Indicator tracks fiscal success,"
- 1B2 Replace first paragraph with "Prior to 1993 Missouri State University treated long-range plans casually. Since producing Welcoming the 21st....." Does this section answer all items mentioned in the core component?
- 1B3 Remove general education program from the first paragraph.
- 1C Include our partnerships with MBE and WBE Public Entities Diversity Committee (Matt Morris can fill in details.)
- 1C Need examples of initiatives from Division of Diversity and Inclusion (Ken send us a list or, better yet, your application for the award!)
- 1C Remove the last paragraph.
- 1C1 Need to mention the climate study timeline and where we are as of early spring.
- 1C2 Need to mention all committees on campus who are working on diversity issues. No one knew what the last paragraph meant so we either need some data or we need to remove this.
- 1C2 Definition of "trending toward sustained excellence" Trending up or down?
- 1D1 Mention the Foreign Language Institute
- 1D2 Start this section with "As a state supported institution audits are required."
- 1D2 List of examples: pay increases, money back to colleges, colleges get to keep carry forward
- 1D3- Partnerships new Center for Community Engagement; Mention partnerships with UMKC and S&T

Accomplishments – The four seem to be resonating as the winners!

Areas of Concern – Put a more positive spin on these!

- 1. The public affairs mission has been incorporated into general education and every undergraduate degree program at the university in the form of a student learning outcome with measurable goals. Assessment is ongoing and we will need to continue to find fresh ways to incorporate the mission into the curriculum at all levels, as well as all aspects of campus life.
- 2. While much progress has been made on diversity, with significant increases in the student body, the University continues to explore opportunities to achieve more diversity in its workforce and to provide more professional development opportunities for everyone on campus.

The committee was charged with reviewing Criterion 2 before the next meeting.
