2. Risk Management Cybersecurity Subcommittee

Rob Martin/Jeff Coiner

- a) Cybersecurity training and email phishing Simulation
- We have purchased licenses for cybersecurity training from MoreNet. We plan to roll out training before school starts for faculty and staff.
 We are working with Human Resources to deliver the training modules through the My Learning Connection. The product is called InfoSecIQ. We plan to run additional phishing campaigns sometime after the start of the Fall semester.
- b) Account Lifecycle
- We are working to create an account lifecycle policy to document when computer systems and email accounts are available for employees and students. Right now, we have accounts that are no longer needed that increase the risk for a cybersecurity incident. We plan to discuss with MSU legal team and Internal Audit, along with others in hopes to solidify a more effective and efficient lifecycle for MSU accounts. We are looking at the next steps we can take without impacting anyone in a negative way.
- 3. Banner Move to Oracle Cloud

• Rob and his team are working with Oracle to move the ERP infrastructure from our physical data centers into a cloud environment called Oracle Cloud Infrastructure (OCI). There are several reasons we have chosen this avenue. There are the licensing benefits which will save MSU money. The goal is to make this transition as transparent as possible to the user community. We're in discussions with a consulting firm to help with this project, and to do some transformation work on our current ERP infrastructure. We want to move from a legacy model

to containerized technology model. This will automate our infrastructure in such a way we can respond more effectively and put us in a better position for disaster recovery and scalability.

4. Classroom Computer Upgrade Status

- We have installed 280 new computers in classrooms out of 365. Of those, 14 are IMACs down in Brick City and a handful of areas around campus. Brian Leas in the classroom instructional technology group is upgrading classrooms and is very close to completion. We are on track and will be ready for Fall 2022. With the help of our networking team, we're able to start a pilot with networking switches in classroom parts. This is more efficient, and the AV components can run through the network now. We have received positive responses about the software installed in the classrooms.
