### Your Site

#### Description of the activities that occur at your site:

I am a clinical psychologist in an integrated pediatric primary care setting. We would have some opportunity to work with adults on a part-time basis at another clinic as well (Southside Behavioral Health).

In regards to my work, I specialize in treating behavior disorders and trauma in children. I do testing and therapy:

-Testing primarily includes ADHD evaluations, often with cognitive testing (Wechsler instruments, NEPSY, DKEFS, Conner's, CBCL).

-Treatment primarily includes 30- or 50-minute individual sessions (primarily CBT and TF-CBT), parent training, and I am a certified PCIT therapist. Of note, any PCIT involvement would include observation and exposure to the model but not full training for the treatment.

#### Description of practicum students' duties at your site:

My agency follows CMS guidelines which specify that the billing clinician must be present in sessions, so I supervise with a co-therapy model (which means I am present for all sessions). With this in mind, the site may be good for students earlier in their training versus those wanting a more independent setting.

Students would begin by observing therapy or testing sessions, then co-lead, then lead sessions under my observation (as they advance in their training). Students are responsible for documentation of their patients using an electronic medical record (EMR) system.

#### Type of population with which students would be working (e.g., adults, adolescents, children, physically challenged, cognitively challenged, etc.):

The majority of time would be spent with children and adolescents, ages 2-17, and/or parents/families. Some opportunities are available with adults at a secondary site under a secondary supervisor (Dr. Steve Finzo, PsyD, LP).
