Your Site

Description of the activities that occur at your site:

Center For Addictions is an outpatient addiction treatment program offering multiple levels of intervention for adults ages 18 and over. Patients are provided with addiction education, relapse prevention education, group and individual therapy, community support services, leisure education, and social skills and life skills training, in addition to other interventions, such as medical detox, psychological evaluation and services, and family therapy when needed. CFA utilizes the disease concept, 12 step orientation, cognitive-behavioral therapy, rational emotive therapy and motivational interviewing to assist patients in their recovery.

Description of practicum students' duties at your site:

Students working with our agency may be asked to participate in many areas of patient care including intake/assessment, treatment planning, case management, community support work, patient education, recreation therapy, social and life skills training, individual, group and family therapy, and discharge planning. Practica/internships will be tailored to fit the needs and interests of each particular student and the requirements of their degree program.

Type of population with which students would be working (e.g., adults, adolescents, children, physically challenged, cognitively challenged, etc.):

Adults, ages 18 and over whose lives have been negatively affected by addiction.

Our Students

Undergraduates

Our undergraduate students typically are juniors and seniors with 17-35 credit hours in Psychology. There are exceptions. If you have any special requirements for students who apply at your practicum site, please describe them.

In order for both students and CFA to benefit fully from the internship experience, we require that a student be able to spend at least twelve to fifteen hours per week with our agency throughout the semester. Many students are with us thirty or more hours per week, depending on the requirements for their respective degree. Students must have senior standing to be eligible.

Graduate Students

Our graduate students are students at the end of their first year or some time during their second year in the clinical track of our graduate psychology program. These students need direct service contact with clients, and also need weekly supervision from a licensed mental health professional. Is your site interested in working with our graduate students?

Because we have both day and evening programs, schedules can be flexible depending on the individual needs of the student and requirements of their particular school. Our activities run Monday through Thursday from 8:30 a.m. to 9:00 p.m. and Friday from 8:30 a.m. to 3:30 p.m.

Center for Addictions is a part of the larger CoxHealth enterprise and as such students will be expected to comply with all CoxHealth policies, including the dress code.
