

Programming Report

(Trainings, Outreach, Education, and Programming)

Due to the COVID-19 Pandemic, most programming was delivered virtually

SOAR Parent Presentations (June 7-August 15, 2020) –Assistant Dean of Students and Director of Student Conduct, Dr. Andrea Weber, and Assistant Director of Student Conduct, Chris Hanna, in collaboration with representatives from the Springfield Police Department and Missouri State University's Office of University Safety facilitated brief presentations to parents twice weekly on policies, safety and behavioral expectations for prospective students.

Hall Director Training (August 2020, January 2021) – Assistant Dean of Students and Director of Student Conduct, Dr. Andrea Weber and Assistant Director of Student Conduct, Chris Hanna, facilitated three trainings for hall staff on adjudicating conduct cases and use of the conduct database, Maxient.

Trivia Tuesday (August 2020- December 2020) - The Office of Student Conduct aims to ensure that students are educated on how to uphold the values of Missouri State University's Public Affairs mission. To achieve this end, the Office of Student Conduct offered weekly questions on social media platforms for students to learn more about the Code of Student Rights of Responsibilities, Office of Student Conduct, the conduct process, and civility. This project was led by Graduate Assistant for Student Conduct, Chase Stockton.

Hazing Prevention Event (September 23, 2020)- Assistant Director for Student Conduct Chris Hanna, in partnership with the Office of Student Conduct, coordinated a hazing prevention event for members of the Fraternity and Sorority Life community. This event focused on identifying what hazing is, and ways to avoid hazing practices and mitigate other risking behaviors within the context of a Fraternity or Sorority chapter.

Fraternity and Sorority Life- New Member Video (September 27, 2020)- It is one of the primary missions for Office of Student Conduct to educate student organizations on the conduct process. Assistant Director for Student Conduct, Chris Hanna, and Graduate Assistant for Student Conduct, Chase Stockton, recorded a presentation for new members of the FSL community introducing the Office of Student Conduct, the student organization conduct process, and students' role in that process.

IDS 120 Course Presentations (September 30, 2020) - Chris Hanna, Assistant Director for the Office of Student Conduct and Graduate Assistant for Student Conduct, Chase Stockton, facilitated a presentation to Interdisciplinary Studies course participants on the conduct process, role of the office, Code of Student Rights and Responsibilities, and the impact of conduct violations.

Fall Fraternity and Sorority Life Hearing Board Training (October 28, 2020)- It is the role of the Office of Student Conduct, in partnership with the Office of Student Engagement, to recruit and train a hearing board for FSL conduct procedures. Assistant Director for Student Conduct, Chris Hanna, Graduate Assistant for Student Conduct, Chase Stockton, working with the FSL justices and Office of Student Engagement, presented a training for the FSL Hearing Board. This training included an overview of the student organization conduct process, relevant policies implicit bias, case studies, and a mock hearing.

Election and Expressive Activity Outreach (November 2020)- In preparation for the 2020 Presidential Election Assistant Director of Student Conduct, Chris Hanna, and Graduate Assistant for Student Conduct Chase Stockton created marketing materials blog post, and social media outreach campaign centered around educating students on the Expressive Activity Policy and components of practicing civility in the election context.

Association for Student Conduct Administrators Regional Conference (December 4, 2020)-Graduate Assistant for Student Conduct, Chase Stockton, attended the ASCA Region IV conference to hear from another student conduct professionals from the region and remain updated with best practices.

Masking Outreach (December 2020 and May 2021)- Graduate Assistant for Student Conduct, Chase Stockton, in partnership with Student Government Assocation, Plaster Student Union, Campus Recreation, Residence Hall Association, and University Safety, created an outreach program to encourage and reward proper masking and adherence to the University masking policy.

Fraternity and Sorority Life Leadership Retreat (January 17, 2021) – Assistant Dean of Students and Director of Student Conduct, Dr. Andrea Weber, facilitated a presentation on the conduct process for members of the Fraternity and Sorority life community. This training included an overview of the Fraternity & Sorority Life Governance Statement and an opportunity for individuals to ask questions about the investigation process.

Association for Student Conduct Administration Conference 2020 (February 5-9, 2020) – Assistant Dean of Students and Director of Student Conduct Dr. Andrea Weber and Graduate Assistant Chase Stockton attended the annual ASCA Conference to further enhance our knowledge of the field and remain updated with best practices.

Spring FSL Hearing Board Training (February 23, 2021, and March 4, 2021) - It is the role of the Office of Student Conduct, in partnership with the Office of Student Engagement, to recruit and train a hearing board for FSL conduct procedures. Assistant Dean of Students and Director of Student Conduct Andrea Weber and Graduate Assistant for Student Conduct, Chase Stockton, working with the FSL justices and the Office of Student Engagement, presented a training for the
