X. Old Business

- Voting on Resolution Bill was tabled by Pi Kappa Phi and seconded by Pi Kappa Alpha until a later date
 "BE IT ENACTED BY THE INTER FRATERNITY COUNCIL HERE ASSEMBLED THAT:
 - SECTION 1.** IFC has determined the official recruitment period run from August 20th to August 23rd, and that a "no-bid period" be enacted beginning August 24th and ending August 31st.
 - SECTION 2.** "No-bid period" is defined as a time in which no bids should be distributed in any capacity.
 - SECTION 3.** The Inter-Fraternity Council Vice President of Recruitment will oversee this policy.
 - A.** The Inter-Fraternity Council Vice President of Recruitment must make sure that bids are readily available as soon as the recruitment period begins.
 - SECTION 4.** If passed, the dates reflected on this bill will be scheduled immediately.
 - SECTION 5.** All laws in conflict with this legislation are hereby declared null and void."
