# **Council Charge**

#### Charge 1

# PAAC Primary Administrative Actions, Accomplishments, Efforts, and Guests

The following page contains highlights of the actions, accomplishments, and efforts of the PAAC for the 2018-2019 academic year. Administrative actions are defined as specific actions completed by the PAAC. Accomplishments are defined as initiatives introduced by the PAAC that led (or could lead) to the introduction of a related action by the University. Efforts are defined as items where the PAAC attempted to measure, initiate, or improve a process or ideas that may be yet incomplete or not able to be measured.

#### **PAAC Administrative Actions**

- In coordination with the Curtis P. Lawrence Excellence in Advisement Awards, the PAAC selected Jessica Silvey in the Office of Student Development and Public Affairs for the Excellence in Advisement Support Award. Maile M.B. Goss Graduate Assistant in the English Department received the Excellence in Advisement Graduate Student award. Jessica Bendure was selected as the winner of the Curtis P. Lawrence Excellence in Advising professional advisor category, and Daniela Novotny was recognized in the faculty advisor category.
- The PAAC asked for volunteers to extend their two-year term for a third year to reestabilish a balance in the membership rotation. Because some members had to end their service on the committee early, the PAAC membership had seven new members in odd numbered years and just three new members in even numbered years. The COAL representative, Rhonda Stanton and the DARR Agriculture representative will continue to 2020, giving the PAAC five openings for membership each year. This should help balance the committee giving it a consistent basis of historical knowledge and participation as well as new membership, new enthusiasm and new ideas.

# **PAAC Accomplishments**

- The Finish in Four subcommittee worked with a design team and created a graphic and provided training on the topic. The logo can be obtained by contacting Tracey Glaessgen.
- Signal Vine messaging platform was purchased for the 2019-2020 academic year for a limited 5000 participants. The PAAC's subcommittee contributed insight and feedback for the selection process of this messaging system. The committee conducted a survey of academic advisors about current texting /scheduling practices as well as desired tools and features for texting and scheduling software. There is hope to expand the contract in the future to be used by a larger number of advisors and reach additional students/advisees. Appointment scheduling tools are still of significant interest to advisors and additional research is needed for this to evaluate software/platform options and integration with Banner and Signal Vine.

#### **PAAC Efforts**

- PAAC members created a list of ideas to increase the awareness of Advising Council as well was ways to increase awareness of advisors and advising.
- PAAC members and the subcommittee on messaging and scheduling software are interested in continued efforts to add scheduling and appointment reminder tools. As a result, Amie Squibb in Enrollment Services is continuing to explore scheduling options and integration with Banner and Signal Vine.
- The PAAC generated a lengthy list of potential Advisor Forum topics for the 2019-2020 academic year that connect with the NACADA Core Competencies. Kathy Davis will use this list to create the schedule of Advisor Forums and Advising Workshops for the coming year.

## **PAAC Guests**

- Amie Squibb (Enrollment Services System Coordinator) -Visited to discuss text message
  utilization for advising and the results of the advisor survey regarding messaging and
  appointment scheduling software. (December 2018)
- Rob Moore (Financial Aid) Presented on "Paying for College Student Financial Aid."
   This presentation addressed the common issues students encounter with financial aid as well as broad rules and deadlines. Many advisor questions and concerns were addressed during this presentation and there was strong interest in asking Financial Aid to participate in an advisor forum or visit departmental meetings. # **PAAC Unfinished Business and Future Opportunities**

- Participate in the evolution of the Student Educational Planner (SEP) template tools as students as well as academic advisors and departments have access to this tool.
- Evaluate the impact of messaging on advising at MSU for Advisement Centers and advisees. This information can be used to potentially advocate for messaging to the broader student and advisor populations.
- Continue to research scheduling software/platform options and advocate for those tools as mentioned earlier in this report.
- Discuss opportunities for advising and advising related resources as they affect opportunities to retain students as well as recruit-back students who have not finished a degree as a mechanism to support student enrollment/retention goals of MSU.
- During our initial goal-setting meeting for this academic year, there was discussion about supporting academic advising scholarship and research. This could take many forms: discussion groups reflecting on advising publications, writing teams collaborating on practitioner based articles or research articles, and more. MSU has a long-standing reputation of excellence in the field of academic advising and this would continue that

excellence and foster growth for advising at MSU and in the broader advising community.

# **PAAC Chair Outgoing Wrap-Up**

Serving on this council has been amazing. Sharing ideas, resources, and goal setting with a set of faculty and staff who truly care about students has been a highlight of my year. I am proud of the hard work of the PAAC and their endless energy for providing quality advising to students and enhancing advising at MSU.
