Rationale and Comments: Missouri State University has submitted a Quality Initiative Proposal that has significant potential to provide impact on the institution and its academic core. The inclusion of an assessment of the public affairs mission with a commitment to diversity would serve as a stellar addition to student learning outcomes assessment. Additionally, the commitment to the inclusion of cultural competency, ethical leadership, and community engagement learning outcomes strengthen the Quality Initiative.

Rationale and Comments: Missouri State University has very succinctly defined the purpose of the initiative and has clearly stated the five goals to be incorporated into the project. We do have some concerns as to the solicitation of faculty for inclusion in the sample for the evaluation of artifacts as our experience has proven that faculty

members are not always forthcoming regarding participation in these types of initiatives. Our suggestion would be to include all faculty members in the sample and conduct a random generation of courses that would submit artifacts. Overall, the plan to accomplish the initiative is well-constructed and very feasible.

Rationale and Comments: Missouri State University has clearly stipulated the inclusion of senior leadership and has involved key personnel in the quality initiative process. Appropriate resources have been devoted to the initiative and the hiring of a Director of Assessment is a crucial step in accomplishing the initiative. The institution's plan for integrating the initiative into continuing college operations is sound in nature. The institution has identified potential obstacles but it was not clear how the institution would cope with these potential issues.
