The Missouri State University precollege program provides qualified students with an opportunity to earn college credit prior to high school graduation. Credit earned under this program will be applicable toward a degree at Missouri State and is generally transferrable to other accredited colleges and universities. Because each institution establishes its own transfer credit policies, Missouri State cannot guarantee transfer of credit to another institution. Two types of courses are available through the precollege program:

- 1) **Campus based courses:** These are regular courses taught by University faculty either on the campus or through designated off-campus locations (e.g., via interactive video) and available to all Missouri State students. To be eligible to take campus based courses, you must have completed your sophomore year of high school and have at least a 3.00 grade point average on a 4.00 scale. An ACT composite score of 21 or higher (or an equivalent score on the PLAN or SAT) is also required.

Students applying for campus based courses must provide a copy of their high school transcript with this application.

- 2) **High school based courses:** These courses are offered by Missouri State through high schools. Generally, they are taught by high school faculty, offered for dual credit as part of the regular high school curriculum, and available only to students from the high school through which they are offered. To be eligible to take high school based courses juniors and seniors must have at least a 3.00 grade point average on a 4.00 scale, and have an ACT composite score of 21 or higher or an equivalent score on the PLAN, PSAT, MAP or SAT. Freshmen and sophomores may be admitted under special circumstances. Freshmen and sophomores must score in the 90th percentile or above on the ACT or SAT with a recommendation from their high school counselor and the college academic department official stating that they can benefit from dual credit in the specific course and learn at the collegiate level.
