## **COMMENTS:**

This project removes the existing built-up roofs and insulation down to the roof deck at Garst Dining Center. It will be replaced with a modified bitumen roofing system with a 25-year warranty. Additionally, this project includes new flashing at all penetrations, maintenance on the metal roof, repairs to water damage on the ceiling, and new paint to match the existing finishes. Work is scheduled to be completed by the fall 2024 semester.

Pursuant to RSMo 34.046, which allows Missouri State University to participate in contract agreements established by other public entities, the University is utilizing the Sourcewell Contract MO-R6-R02-051222-QCR with Queen City Roofing and Contracting Company to perform the work under this contract.

This project will be paid from the Garst, Roof Replacement budget funded by the Residence Hall Reserve (\$820,000.00) budget.

**Software for Faculty Database Office of Academic Affairs, West Plains** 

\$292,627.04 (Five-Year Agreement)

Pursuant to University policy, which addresses justification for making awards on a single feasible source basis, the Office of Academic Affairs, West Plains, has requested a five-year contract of Faculty Success, Review, Promotion and Tenure, and Planning and Self-Study by Watermark software in the amount of \$292,627.04.

Faculty Success by Watermark software provides a database system that collects, stores, and reports activity of the faculty. These activities include producing curriculum vitae for state mandated reporting of faculty credentials, producing required reports for accreditation purposes, and producing applications for tenure, promotion, and annual compensation.

In addition, the Watermark Review, Promotion and Tenure (RPT) workflow module will enable the University to make better use of the accumulated faculty data to be used as part of the annual review process, tenure and promotion, and other review processes that require a workflow.

Finally, the Watermark Planning and Self-Study module provides the University with a tool to drive systematic planning and outcomes assessment and help with accreditation report writing and continuous improvement processes.

Watermark's Faculty Success, RPT, and Planning and Self-Study allow agreements of its software in increments of three or five years only. The University has chosen to implement five-year agreements on all three products.

Total cost of this five-year software agreement is \$292,627.04, comprised of \$79,410.95 for Faculty Success, \$47,815.73 for RPT, \$145,750.36 for Planning and Self-Study, and \$19,650.00 for implementation.

As the manufacturer and distributor, Watermark is the sole source provider of the software and support services for Faculty Success and RPT by Watermark.

Public Broadcasting Service Membership Dues \$675,000.00 Broadcast Services – Ozarks Public Television (OPT) (Estimated One-Year)

Recommend approval to process payment for FY25 to Public Broadcasting Service (PBS) as a single feasible source (SFS 5836) for FY25.

Each year, PBS programming fees are calculated based on a formula that accounts for OPT's fundraising totals in the prior two-year period.

Subject to ongoing need and satisfactory performance, future annual payments will be made on a continuing basis.

PBS provides Ozarks Public Television with prime-time programming, daily children's shows, and *PBS Newshour*.

Membership with PBS is required in order to provide programs that are distributed as part of the Public Broadcasting Service. Affiliates may identify themselves by using the PBS logo, which is a registered trademark of PBS.
