

Citizenship and Service-Learning Oversight Committee Report Faculty Senate Report: 2020-2021 Summary of Activities

Faculty Senators:

Charge

The CASL Oversight Committee has worked to execute its charge to "monitor and evaluate the CASL Program for the Senate" according to Senate Action 10-95/96. This standing committee of the Faculty Senate has fulfilled its task to maintain the academic credibility of the service-learning program. The CASL Oversight Committee supervises new service-learning options that are added to individual departments and approves all course syllabi of faculty integrating service-learning into their courses.

Overview for the Year

During the past academic year, **752** course sections were offered as service-learning courses or pathway courses to service-learning—up from 750 course sections during the AY 19-20. Three hundred and twenty-one (**321**) MSU Faculty/Staff offered service-learning courses. As a reminder, students are not graded on their time out in the community, but on the learning demonstrated as the students integrate their material back into the classroom through reflective assignments chosen by faculty members and approved by the CASL Oversight Committee.

Through the CASL program in 2020-2021, **8,579** students contributed **104,466** hours of service to the community as faculty members used this pedagogical tool to underscore academic objectives. These contributed hours represent a value of **\$2,711,937**.

Alignment to Missouri State University's Long-Range Plan

Missouri State University recently released the 2021-2026 Long-Range Plan. In the plan, MSU stated "Community Engagement will be more fully integrated into academia" (LRP, pg. 41). As part of the plan, faculty can apply for teaching waivers for large community service projects they are involved in and are encouraged to become involved in significant community projects. The plan further noted with community engagement being a core component of the University's Public Affairs mission, "all students will be required to take at least one additional service-learning course in their major before they graduate" (LRP, pg. 38), over and above their community engagement project for GEP 101.

Faculty Support and Learning

To support faculty with this, the CASL Oversight Committee, along with Dr. Katherine Nordyke, Director of Citizenship and Service-Learning, and CASL Oversight Committee chair, Dr. Alan Tinkler, will host several Coffee & Conversation sessions, Brownbag Lunch Sessions and workshops throughout 2022 to answer questions and assist faculty in making their courses service-learning courses. Additionally, the CASL Office will have a limited number of Service-Learning Faculty Development Stipends and Service-Learning Research Grants available each year to assist faculty in service-learning course development.
