## b. 2023 Gen Ed Course Evaluations

- i. We will have to review 58 course reports this year. So far 18 have been submitted. People asked for extensions.
- ii. Katie will assign two-people to review each course report. We will send further information. Katie, Kristen, and Ximena will be the team leaders. We need at least two people reviewing each report. Expect an email with all the instructions and links.
- c. The Provost asked Shubha to share <u>this bill</u> with us. We only have the summary. The full bill is not available yet. Provost requests feedback from CGEIP before the end of

the semester. Katie will write up a statement to send to CGEIP members. Shuba needs to share response at December 13 meeting.
Summary:

- i. Increases the transferrable lower-division core curriculum credit hours from 42 to 60, to be developed by June 30, 2025, for the 2025-26 academic year.
- ii. Ensures students who complete the 60 credit-hour block at one public institution receive credit towards their degree program when transferring to another public institution.
- iii. Completing an associate degree satisfies all lower-division core curriculum requirements at the receiving institution, eliminating additional general education requirements for the same program.
- iv. Students who complete general education requirements (without an associate degree) at a public institution have these credits fully transferable and deemed completed at the receiving public university.

In general, committee members disagreed with the bill:

- 1. The language is confusing.
- 2. The number of transferable credits is not currently set at 42.
- 3. The bill can potentially undermine the quality of our programs.
- 4. Would those transferable courses apply to any degree?
- 5. The committee needs more information.
