  - a. February 2024 minutes Approved with a change on the spelling of a name.
  - b. Update on CORE 42 meeting.
    - i. The group got together yesterday. They voted that CGEIP should oversee Core 42 and asked for a faculty senate vote. What would be the process to approve Core 42 courses? A course would have to be in the curricular action workflow. As of now the two processes are not integrated. We propose to have the Core 42 courses to follow the new general ed process: first goes to us, then the faculty senate, then the state. Can we leave college council out of the process? CGEIP represents all the colleges.
    - ii. Do we want a resolution for Faculty Senate where we add Core 42 to the purview of CGEIP? And for Core 42 courses to follow the same process as CGEIP?
      - Passed
    - iii. If we do this soon enough, Beth Walker will get it on the agenda for next meeting. Katie will share the language with the committee before sending it to Beth.

- i. For next year, we might need to change the language to say that if courses do not turn in their reports in two cycles, they can lose their general ed status. Right now there are no consequences for not turning in reports.
