II. Old Business

Talked about SFR 250 – Foundations of American Education

- The item is not on the agenda.
- The proposal was not shared with committee members.
- There is a question about the curricular change/proposal being in the system CAW. New members to the committee have not seen the original documents.
- Two members had questions about the course fitting the Gen Ed category of cultural competence.
- They raised questions about the inter and intracultural comparisons not appearing on the syllabus, but also thought the course was a better fit for public issues. The focus is American Education System.
- There was discussion/suggestion about changing or adding to the description of the course or the title of the course.
- It is a course in the catalog, it has not been taught, and it is presented as new to Gen Ed.
- Kelly Wood noted that in the document https://www.missouristate.edu/Provost/_Files/_GenEdReview/Structure_GenEd_Program.pdf , we require Cultural Competence courses to use General Goal 13 and one other 12 or 14.

d. Gen Ed Course Coordinator Training update.

- Lu Maimone asked what the purpose of the reports from the Gen Ed courses is. If the purpose of the review of reports is evaluation, we are missing the action taken after the review.
- Kelly Wood proposed to follow up with faculty submitting reports to have feedback incorporated into the content of the class
- Katie Hoegeman wants us to think of the review of reports as assessment and NOT as program evaluation. It is about meeting or not meeting the general goals.
- The original purpose was a community approach to assessment.
- One reason we chose to ask for reports every other year was so that coordinators could focus on only 1 goal at a time vs. one big report every 5 years.
