Reason for proposed change:

Our current prerequisite hinders the students who completed MTH courses (and who have transferred credits or AP credits for MTH courses) from enrolling in CHM 160. This

is due to the fact that MSU's system determines the "eligibility for MTH 136 or higher" based on ACT score, SAT score or Department of Math Placement score on file (but not based on course work).

This proposed change allows for those students to enroll in CHM 160 as long as they have the credits for an appropriate MTH course (including transferred credits and AP credits).

All students who meet the current prerequisite will remain eligible in enrolling CHM160. Therefore, no students will be negatively impacted by this change.

This change does **not** affect course assessment (e.g. student learning evidence/outcomes).
