I. Call to order

Jamaine Abidogun called to order the regular meeting of the Educator Preparation Provider Executive Committee at 3:06 p.m. on March 27, 2017 at Hill 308.

II. Approval of minutes

The minutes from March 1, 2017 meeting were approved. Minutes stand.

III. Discussion Items

- 1. Chris Craig:
 - a) Tentative dates are set for the assessment meetings. April 10 for advanced programs and April 21 for initial programs. Dates will be reinforced at the next EPPC meeting. Karen Engler and Chris Craig will work with James Sottile in advance of those meetings.
 - b) An AAT meeting is scheduled with Frank Einhellig for Wednesday, March 29, 2017. Resolutions from various groups will be discussed as well as faculty concerns. COE was set up for automatic transfers to accept Community College EDC345 substitution as PEU016 as early as June 2016. Discussion. The AAT agreement should go through a formalized process. Concerns for current form of AAT include:
 - EDC 345 is a product of an EPPC Diversity Ad Hoc committee. The strength and expertise of the course should be maintained. The Diversity Committee should be charged with continual oversight and support of EDC 345 curriculum.
 - This potentially opens the door for all Missouri community colleges.
 - Is reverse transfer an option?
 - Since AAT is in draft form; can it be stopped?

We need to seek solutions. Discussion. Copies for Wednesday's meeting were decided on. Chris Craig will update EPPC at the April meeting.

Faculty would also like to share with Dr. Einhellig that outcomes from high impact initiatives that under consideration by DESE committees are often not shared with EPPC by our ex-officio representatives until after all decisions or outcomes are decided. EPPC would like more proactive involvement with DESE initiatives.
