

# EPP MSED Committee Meeting Minutes

May 2, 2016

#### I. Call to order

Jamaine Abidogun called to order the regular meeting of the EPP MSED Committee at 1:01 p.m. on May 2, 2016.

## II. Approval of minutes from last meeting

A quorum was established.

The minutes from April 4, 2016 were approved.

### III. CAEP and MSED Assessment Update

- 1. Jamaine Abidogun spoke on behalf of Chris Craig who was unable to attend.
  - a. GPA must be 3.0 overall and not based on only the last 60 hours. This will require a catalog change. There can be exceptions.
  - b. MoCA is not acceptable as test for admission. It is not nationally normed. While it could be submitted for approval as admission test; DESE would be the appropriate organization to do so. GRE or MAT are acceptable tests for admission.
  - c. Assessment must demonstrate content. SFR 750 will suffice.
  - d. Proposal (We need to agree on four assessments, two unit wide):
    - i. Practical Skills assessment is not needed. No rubric required.
    - ii. Assessment 1: Diversity assignment content (SFR 750) can be used as pedagogy assessment. There is a recommendation to add a button in Degree Works for Field Experience assessment.
    - iii. Assessment 2: Clinical Log is now in Taskstream. There is no one assigned to assess or review the student submissions at this time. It could be used as part of the research component (advanced content through field experience work). Discussion.

#### Sidebar:

 Eric Sheffield attended the GPAC meeting earlier in the day. The group would like to have two GPAC representatives and two MSED representatives to draft assessment rubrics over the summer for faculty input in the fall. This may require compensation based on increased workload.

- iv. Assessment 3: Comprehensive Exams must be a rubric. Program Coordinator will work with assigned faculty for student to get into Taskstream.
- v. Assessment 4: Research Project.

- There is a recommendation to add Degree Works-style radio buttons for assessments.
