NEW COURSES

EDT 650 – Selection and Utilization of Educational Technology

Motion to not recommend based on errors and editorial inconsistencies. Second. Discussion. Motion carried.

The Department Head should contact Dr. Homburg to request that he reject the proposal so necessary changes can be made.

ELE 771 has progressed through Graduate Council. When asked, Dr. Cunningham explained that it is not part of certification therefore is not under EPPC review. Discussion. There is consensus that the course should have come before EPPC as we do not review only certification courses.

 - Option 1: Recommend that deans, department heads and college curriculum committees be advised on the curricular review process and/or the appropriateness of minors for teacher education students.
 - Option 2: Recommend that the curricular process system be edited to advise curricular authors that selecting BSEd, BME, etc. for program changes will trigger a review of the program proposal by the EPPC.
