#### **NEW COURSE**

SEC 439 Vocational Business Education Instructional Strategies

Dr. Stephanie Huffman spoke to the proposal. Dr. Huffman gave background information on the new program. It used to be in COB but was discontinued due to low enrollment numbers. Dr. Huffman taught vocational business education before and wanted to bring the program back but keep it in the RFT Department in the College of Education. Dr. Huffman had conversations with Drs. Craig, Meinert, Hough, and Engler. All were supportive. Matrices have been approved by DESE.

Business courses are already on the books but are in the process of being cleaned up and updated.

## **COURSE CHANGE OR DELETION**

SEC 526 Coordination of Cooperative Education

Dr. Stephanie Huffman spoke to the proposal. The course description has been updated. It will be 3 hours instead of two.

#### EDUCATOR PREPARATION PROVIDER

### SEC 626 Coordination of Cooperative Education

Dr. Stephanie Huffman spoke to the proposal. This is a graduate course with an updated description. Hours have changed from 2 to three.

# SEC 522 Philosophy of Vocational Education

Dr. Stephanie Huffman spoke to the proposal. The course description has been updated and the title changed to separate it from the graduate course, SEC 622.

### SEC 622 Philosophy of Vocational Education

Dr. Stephanie Huffman spoke to the proposal. This is a graduate course with an updated description. Language has been removed that states students can get credit for SEC 522 and SEC 622. This is no longer possible since the courses are no longer separate.

### SEC 527 Teaching Adults in Vocational Education

Dr. Stephanie Huffman spoke to the proposal. This course is on books. The title is being changed to disconnect it from SEC 627.

#### SEC 627 Teaching Adults in Vocational Education

Dr. Stephanie Huffman spoke to the proposal. Language will be removed that students cannot receive credit for SEC 527 and SEC 627. Students will be able to earn credit for both courses.

### PROGRAM CHANGE OR DELETION

Secondary Education/English-MSED (Accelerated)

Dr. Karen Engler, on behalf of Heidi Hadley, spoke to the proposal. The GPA requirement for admission is going to be dropped from 3.25 to 3.0. The Shakespeare course is being removed because students are already required to take a Shakespeare course.

### Secondary Education/English-MSED

Dr. Karen Engler, on behalf of Heidi Hadley, spoke to the proposal. Shakespeare is being removed as a requirement and will now be an elective. If students have not taken a Shakespeare course, they will be advised to take one.

#### Teaching, Master of Arts in-MSED

Dr. Stephanie Huffman was present to speak to the proposal. The face-to-face interview was removed during COVID. Students now answer interview questions. If additional information or clarification is needed, Dr. Pam Correl will set up a Zoom or phone meeting.
