#### **APPROVAL OF MINUTES**

The minutes of the March Senate session were approved as distributed.

#### **ANNOUNCEMENTS**

- 1. Faculty-Student Judicial Commission (FSJC) results: Dan Kaufman from Philosophy, John Havel from Biology, and after breaking a three-way tie, Mary Ann Jennings from the School of Social Work were elected to serve.
- 2. In the materials on the table is a statement prepared by Chair-elect Kane and Chair Richter on the issue of background checks, which they believe reflects the position the Senate took earlier in discussing this issue. The Board will be moving to implement such checks in the final candidate for tenure-track positions at the May Board meeting. Considering the Board's stance on background checks, Chair Richter said the Senate members will be asked to support the Executive Committee's strategy to present this statement to the Board. This will come up under new business, most likely at the Tuesday meeting.
- 3. If necessary, the April Senate session will be continued on Tuesday, April 17, in Karls 102. President Nietzel will report on the 2007-08 budget on Thursday, April 19, in Glass 101.

- 4. Chair Richter announced the compensation survey letters and e-mails have been distributed and the survey is on-line and ready to go. If faculty members will complete the survey, it will help to improve the system in the future. Senators from COBA and CHPA felt the survey was premature as the entire cycle hadn't been completed yet in their college. As background, Chair-elect Kane said the Faculty Concerns Committee had voted to have the Senate Executive Committee distribute the survey since they will be on campus during the summer. He agreed that the two-week deadline could be extended if necessary.
- 5. As the April Senate session is the last session in which he will preside, Chair Richter thanked everyone for their professionalism and support during the past year while he has served as Senate chair.

# CANDIDATE FORUM FOR 2007-08 SENATE CHAIR-ELECT AND SECRETARY OF THE FACULTY

Each of the candidates for Chair-elect (Pauline Nugent and Joseph Hulgus) and for Secretary of the Faculty (Melanie Grand and Rebecca Woodard) gave a brief opening statement. Senate members were given an opportunity to ask questions of each of the candidates in a time format provided by the Senate Chair.

#### ELECTION OF 2007-08 CHAIR-ELECT AND SECRETARY OF THE FACULTY

Immediately following the candidate forum, ballots were distributed to Senate members for voting on the above positions. Pauline Nugent from Modern & Classical Languages was elected as the 2007-08 Chair-elect of the Faculty Senate, and Rebecca Woodard from Health, PE & Recreation was elected as the 2007-08 Secretary of the Faculty.

#### VOTE ON BYLAWS AMENDMENTS PRESENTED BY RULES COMMITTEE

Ballots were distributed to Senate members for voting on the six amendments to the *Bylaws* presented by the Rules Committee at the March Senate session. All six amendments passed by the required 2/3 majority. They will go forward to Administration for approval as **Senate Action 27-06/07** through **Senate Action 32-06/07**.

#### REPORT ON TIME-LIMITED AND NON-TENURED TEACHING FACULTY

In accordance with Senate Resolution 15-91/92, Associate Provost Craig presented the above report concerning the status of time-limited and non-tenurable teaching faculty, a copy of which was previously distributed to Senate members. He said in looking at the tables it is obvious there has been a steady decline in full-time faculty since 2002, and although he didn't have all the variable as to why, he is hoping to work closely with the Faculty Senate on matters such as this. Dr. Craig said salaries are starting to look better and better when recruiting for new jobs.

#### **UPDATE ON PUBLIC AFFAIRS CONFERENCE**

Dr. Ken Rutherford, conference chair, gave an update on the Public Affairs Conference which is to be held at Missouri State on April 17-20. He distributed a Public Affairs Conference brochure and provided some demographic data showing an increase in the diversity of speakers at the conference. A copy of the diversity demographics for the 2005-07 conferences is attached (see Attachment 1 to these minutes). Dr. Rutherford said high school students have also been invited to attend this year's conference.

#### ACTION ON CURRICULAR PROPOSAL - NEW M.S. IN APPLIED ANTHROPOLOGY

Senator Brinker moved for approval of the new Master of Science in Applied Anthropology program (seconded by Senator Nugent). Dr. Michael Hendrix, chair of the Budget & Priorities Committee, reported that the committee had approved the new program unanimously. Dr. Karl Kunkel, head of the Sociology, Anthropology, and Criminology Department briefly discussed the new program. After discussion, the motion was approved by voice vote. It will go forward as **Senate Action 33-06/07**.

Chair Richter announced the next agenda item, the report from the Budget and Priorities Committee on funding of JQH arena, would be presented at next Tuesday's Senate meeting and that he would entertain a motion to adjourn today's meeting. - 1. Chair Richter reported that all six of the *Bylaws* amendments voted on in the April 12 Senate meeting were approved by the required 2/3 majority.
- 2. The deadline for the merit evaluation survey has been extended to May 1.
- 3. The report from the Budget & Priorities Committee on funding of the JQH arena will be given at the May 10 Senate meeting. Chair Richter said there were concerns about the accuracy of information in the report, and the Committee did not have time to meet and discuss it prior to today's meeting. The committee chair has also resigned from the chair position. In light of these developments, the Budget & Priorities Committee and the Senate Executive Committee felt it would be best to postpone the report until the May meeting.

#### REPORT ON 2007-08 BUDGET

President Nietzel gave a PowerPoint presentation of the 2007-08 budget, commented on the campus incident yesterday in which Craig Hall was locked down briefly, and gave an update on the construction of JQH arena. As information, a copy of the budget presentation will be posted to the web. President Nietzel took several questions from those attending the meeting, including questions concerning elimination of retiree insurance, changes to health fund, increasing budget for library holdings, and use of money from SCUF (Student Computer Usage Fund) fees.

#### **UNFINISHED BUSINESS**

There was no unfinished business.

#### **NEW BUSINESS**

Chair Richter referred to the handout on "Proposed Statement on Background Checks" distributed at the April 12 Senate meeting, which contains arguments from the faculty's perspective that he or Tom Kane may use in speaking against a proposed resolution on background checks the Board of Governors will present at the May 17 Board meeting. He asked Senate members to forward any comments or concerns they might have about the statement to either Tom Kane or him. The backgrounds checks issue may also be brought to the floor at the May 10 Senate meeting.

#### ADJOURNMENT

Chair Richter declared the meeting adjourned at 5 p.m. The next regularly scheduled Faculty Senate meeting will be the 2007-08 organizational meeting which will be held on Thursday, May 10, at 3:30 p.m. in PSU 313.

### Amendment to Bylaws - Add Faculty Personnel Management Committee as a Standing Senate Committee

- (a) Purpose
  - (aa) Shall provide faculty input to Academic Council about the allocation of faculty lines.
  - (bb) Shall develop annual targets for faculty hiring by establishing explicit goals on the percentage of FTE faculty who are tenure track, full-time tenure track, and per course faculty members.
  - (cc) Shall report annually in March to the Senate on the annual targets; said report to include statistics detailing progress the university is making towards achieving targeted goals.
- (b) Membership

A tenured faculty member not serving in a full-time administrative position shall be elected by his or her respective college council, based on a nomination from each department/school within that college, at the earliest possible meeting of the college council in the spring semester, and serve a two-year term. A committee member may be elected to more than one two-year term. Membership shall be staggered, with three councils (College of Arts and Letters, College of Business Administration, and College of Education) electing members on odd-numbered years; the other three councils (College of Health and Human Services, College of Humanities and Public Affairs, and College of Natural and Applied Sciences) electing on even-numbered years. Any unforeseen vacancy on the committee shall be filled by the same election process; such election shall occur at the earliest possible meeting of the appropriate council following the vacancy. The chair of the Academic Relations Committee will serve as an *ex officio* member. The Faculty Senate Executive Committee will choose one of the six members to serve as the chair of the Faculty Personnel Management Committee. Senate Action 28-06/07

# Amendment to Bylaws ART I, SEC 1, Membership of the Faculty Senate

To be inserted at end of ART I, SEC 1, Membership of the Faculty Senate:

All academic departments/schools physically located outside the State of Missouri can designate a current faculty member from the Springfield campus to represent them in all areas of concern. By definition, this right shall be, but is not limited to, representation on the Faculty Senate, the Faculty Concerns Committee, and College Council.

### Amendment to Bylaws ART I, SEC 1, H - Terms of Member Service on Faculty Senate

HTerms of Member Service on Faculty Senate

(b) Exception to this rule: A person elected chairperson-elect during the third or fourth consecutive year as a Senator may serve the next two years as chair-person-elect and chairperson of the Senate. A person elected Secretary of the Faculty during the third or fourth consecutive year as a senator may serve the next year as Secretary of the Faculty and is eligible for reelection as secretary for the next succeeding term. Upon completion of such a term as an officer of the Senate that person will not be eligible to serve on the Faculty Senate until the lapse of an intervening year. The past-chair, unless appointed to an administrative position or leaves the University, will serve one year as the chair of Judicial Review and is not eligible for any elected positions in the Senate. When the immediate past chair is unable or ineligible to serve, the next most immediate past chairperson will serve.

  - (b) Shall be composed of three **next most** immediate past-chairpersons of the Faculty Senate who do not hold **full-time** administrative positions.

### Amendment to Bylaws ART I, SEC 8, (1) Executive Committee of the Faculty Senate

ART I, SEC 8 Committees of the Faculty Senate (lines 394-397)

#### (1) Executive Committee of the Faculty Senate

(b) Membership

Shall consist of the chairperson of the Faculty Senate, who shall be chairperson of the Executive Committee; the chairperson-elect of the Faculty Senate, the Secretary of the Faculty, and the past chairperson of the Faculty Senate, and the Parliamentarian, *ex officio*. A past chair who has been appointed to a fulltime administrative position will not be eligible to serve on the Executive Committee. When the immediate past chair is unable or ineligible to serve, the Executive Committee shall consist of the chairperson of the Faculty Senate, the chairperson-elect of the Faculty Senate, and the Secretary of the Faculty. The Chairperson may appoint a Parliamentarian to serve as an *ex officio* member of the Executive Committee if additional parliamentarian expertise is desired. Senate Action 32-06/07

### Amendment to Bylaws Remove All References to University College Throughout Bylaws

Amend the *Bylaws* to remove all references to the University College. One specific Rules Committee amendment is shown below.

ART VI, SEC 10 Origination of Curricular Proposals (lines1375 -1382)

Any substantive change to an existing academic degree program, major, minor, option, or certificate must originate with the formal sponsorship of an academic unit responsible for overseeing that program, major, minor, option, or certificate. In the case of a degree program, major, minor, option, or certificate offered through an individual department/ school, the relevant academic unit would be that department/ school. In the case of each "Special Academic Program," each academic program administered through the University College, and any other interdisciplinary or cross-disciplinary degree program, major, minor, option, or certificate offered outside the structure of a single academic department/school, the relevant academic unit would be the faculty committee charged with overseeing the program, major, minor, option, or certificate in question....
