# Minutes of the January Session of the Faculty Senate Missouri State University 

The Faculty Senate held its regularly scheduled meeting on Thursday, January 17, 2008, in Plaster Student Union, Room 313. Chair Tom Kane called the session to order at 3:31 p.m. Dr. Eric Shade served as parliamentarian.

## APPROVAL OF MINUTES

The minutes of the December 6 Senate session were approved as distributed.

## ANNOUNCEMENTS

1. The Governor's budget proposal is in line with the expectations and assumptions used by the University's Executive Budget Committee. The proposal includes $\$ 700,000$ for "Preparing to Care" to accommodate the education of more health care professionals. The committee has been operating on the assumption of at least a 4 percent pay increase for next year.
2. Faculty members who have roots in southwest Missouri are being recruited to take part in the 2008 Community Caravan. The Caravan is an outreach effort to promote the University to local communities and school districts. Details about this recruitment and public relations effort will be reported in the next Friday Focus.
3. The College of Business Administration's accreditation review was successful, and the accreditation report was extremely positive. Congratulations to our College of Business colleagues on their recent AACSB re-accreditation.
4. In March, nominations for Chair-elect and Secretary of the Faculty will be announced by the Nominating Committee. Nominations may also come from the floor, and it is hoped that senators will identify and encourage our best faculty leaders to run for the positions.

## REMARKS BY BOARD OF GOVERNORS CHAIR MARY SHEID

Ms. Mary Sheid, chair of the Board of Governors, briefly addressed the Faculty Senate and answered questions. She commented that the Board was very excited about the $\$ 4.3$ million dollars that will be coming to Missouri State University and that the Board had worked very hard to bring the proposal forward to the Governor's office. She extended her congratulations to both the College of Business Administration on its recent reaffirmation of accreditation with the AACSB for the business administration and accounting programs and to the Physical Therapy Department upon approval of their doctorate program.

## RESOLUTION FOR DAVID VINYARD

Senator Fuqua moved for approval and Senator Kaufman seconded a resolution in honor of David Vinyard, an accelerated master's student in Chemistry at Missouri State University and the first student chosen as a Rhodes Scholar finalist at Missouri State. The Chemistry Department's departmental Senate representative, Eric Bosch, presented and read the resolution to the Faculty Senate, and the resolution was approved by voice vote. It will go forward as Senate Resolution 8-07/08.

## "FOCUS THE NATION TEACH-IN" PRESENTATION

Dr. Alexander Wait and student Ms. Lindsey Berger announced plans and presented information on sessions of the "Focus the Nation" teach-in being planned on campus for January 30 and 31. A web-cast will be held in Temple Hall, Rooms 1, 2, and 3 on January 30. All events on January 31 will be held in Plaster Student Union, with rooms to be announced at a later date. The schedule of events for the meeting and a pamphlet entitled, "Focus the Nation: Global Warming Solutions for America," were distributed to Senate members, and faculty were asked to encourage their students to attend. A web page outlining the schedule for the event will be announced in the Provost's Communiqué.

## VOTE ON CONSTITUTION \& BYLAWS AMENDMENT PRESENTED BY THE RULES COMMITTEE

Paper ballots were distributed to Senate members for voting on the three amendments presented by the Rules Committee in the December Senate meeting which would revise the Bylaws to indicate that an individual receiving an honorary degree must be living at the time of selection and will receive the honor at the spring commencement; however, if an honoree dies during the interim between selection and the spring commencement awards ceremony, then the award will be presented posthumously. Another amendment would add that (a) individuals at the ranks of Distinguished Professor are eligible for Senate membership, (b) that individuals at the ranks of Distinguished Professor and Full Professor should be represented by a single rank representative, and (c) that the Constitution \& Bylaws of the Faculty be revised to clarify this aspect of membership and representation. (This involves changes to both the Constitution, ART IV, and the Bylaws, ART I, SEC 1.) All proposed amendments passed by the required two-thirds vote.

The amendment to the Constitution will need to be distributed to all full-time faculty for ratification before being made into a Senate action and forwarding to Administration. The other two Bylaws amendments will go forward to Administration as Senate Action 13-07/08 and Senate Action 14-07/08.

## REPORT FROM ACADEMIC RELATIONS COMMITTEE

Dr. Arden Miller, chair of the Academic Relations Committee, presented a revised version of the Attendance Policy for approval (see Attachment 2 to the January Senate agenda). The revisions were made in response to a request from those involved with athletics who felt a more formal procedure needed to be in place for athletes who must miss a class or classes due to their obligation to the University. Senator Finch moved for approval of the revised wording in the Attendance Policy, and Senator Kaufman seconded her motion. Senator Bourhis spoke against the motion, saying the policy already in place was fine and that if certain faculty members were abusing the policy, then they should be dealt with on an individual basis. He also pointed out that the revised policy puts faculty members in a "bureaucratic loop" by requiring them to response in writing in three days for each and every student who must miss class. Several Senate members agreed with Senator Bourhis' position and spoke against the motion.

After more discussion, Senator Zimmerman moved the previous question (seconded by Senator Rovey). By voice vote, the main motion to approve the revised version of the Attendance Policy as presented by the Academic Relations Committee failed.

Dr. Miller presented the Committee's report amending the hiring practices to include more faculty members when forming search committees for department heads. Senator Shoptaugh moved for approval of the report, and Senator Buckner seconded her motion (see Attachment 3 to the January Senate agenda). Tom Wyrick moved to amend the bolded portion of Attachment 3, fourth sentence, to read, "In the case that there are no faculty members selected or available in a particular rank, the Department Faculty may select the names of two members from another rank to forward to the Dean." His motion to amend was seconded by Senator Buckner and then passed by voice vote. The main motion was also approved by a show of hands. It will go forward as Senate Action 15-07/08.

## DISCUSSION AND VOTE ON CURRICULAR PROPOSAL TO DELETE GEP 397 FROM THE GENERAL EDUCATION PROGRAM

Senator Buckner moved to delete GEP 397 from the general education program (seconded by Senator Kaufman). Tom Wyrick, chair of the Budget \& Priorities Committee, addressed the Senate concerning budgetary implications the deletion of GEP 397 might have and distributed a hand out showing faculty resources devoted to GEP 397 for 2007 (not including summer). The information presented indicated that the College of Arts and Letters taught the highest number of in-load sections of GEP classes with 13 sections. According to Dr. Wyrick, the Budget \& Priorities Committee has no budgetary objections to the deletion of the course, but he said this was only part of the story. Ann Branstetter, chair of the Committee on General Education \& Intercollegiate Programs (CGEIP), gave a brief statement concerning CGEIP's decision to remove the course from the general education program.

In response to a question, John Catau clarified that it had been decided to drop the number of hours in the general education by three hours but with the understanding that in the future it will probably ask for those hours back. He said at present there is a possibility that the IDS 110 course may be redone and might be changed from a one-hour class to a two-hour class, which would take back one of the hours being dropped. Chair Kane said the total number of hours for graduation was still 125.

Senator Zimmerman asked if there were any curricular reasons to drop the GEP course, and Dr. Catau responded that it being dropped mostly because of lack of support. He said the only way the course has been supported was because of summer school. He said it has been very hard to find faculty to teach the class and that it just was not working. Graduate Council representative Kelly Copeland spoke in favor of keeping the course, saying she had had a very positive experience when she took the GEP 397
course. After further discussion, the motion to delete GEP 397 from the general education program passed by voice vote. It will go forward as Senate Action 16-07/08.

UNFINISHED BUSINESS - There was no unfinished business.
NEW BUSINESS - There was no new business.

Chair Kane adjourned the meeting at $4: 58$ p.m. The next Faculty Senate session will be held on Thursday, February 14, beginning at 3:30 p.m. in PSU 313.

## Amendment to Bylaws - ART I, SEC 8, B, (1), (a), 3, Committee on Honorary Degrees

Amend the Faculty Bylaws, ART I, SEC 8, B, (10), (a), 3, Committee on Honorary Degrees, to read as follows:

The honoree must be living at the time of selection and must be present at the award ceremony to receive the honer at the spring commencement must be living at the time of selection and will receive the honor at the spring commencement. If an honoree dies during the interim between selection and the spring commencement awards ceremony, then the award will be presented posthumously.

## Amendment to Bylaws - ART I, SEC 1, Membership of the Faculty Senate

Amend the Bylaws, ART I, SEC 1, Membership of the Faculty Senate, to read as follows:
There are two classes of membership in the Faculty Senate: voting members (designated as senators) and non-voting members (designated as delegates). The voting members of the Faculty Senate shall consist of the following senators: the Chairperson of the Senate; the Chairperson-elect of the Senate; the Secretary of the Faculty; representative of academic departments/schools, one senator from each department; representatives of the ranked faculty, one senator from each rank; one representative from among lecturers. each rank: (a) instructor, (b) assistant professor, (c) associate professor; and (d) full or distinguished professor....

## Hiring Procedures for Department Head Searches

## Forming the Search Committee

The Search Committee should have members who have legitimate and direct interests in the selection process. Membership may include faculty, staff, and students, as well as alumni or other outside constituents when desirable. Criteria used in selecting the Search Committee members often include the following:

- knowledge of the substantive area*;
- demonstrated ability in promoting a deliberative process;
- knowledge of the campus and its surrounding communities;
- strong interpersonal and recruitment skills; and
- an ability to maintain a high degree of confidentiality.
*It is not imperative that all members of the search committee have knowledge of the substantive area.
When possible, women and minorities from within the department should be represented on all Search Committees; however, this may not always be feasible. In these instances, consideration should be given to including women or minorities from other departments, administrative units, graduate assistants/teaching assistants and/or alumni/members of the community to serve on the committee.

Faculty will elect two members from each rank within the Department to serve on the Search Committee, whose names they then forward to the College Dean. The Dean will select one of the two faculty members from each rank to serve on the Search Committee, so that each rank is represented on the Committee. In the case that there is only one faculty member in a particular rank, that member may serve on the Search Committee. In the case that there are no faculty members selected or available in a particular rank, the Department Faculty may select the names of two members from another rank to forward to the Dean.

## Confidentiality

In acceptance of Search Committee membership, each Search Committee member assumes responsibility not to divulge any applicant's name or status, or the content of any Search Committee conversation, to any non-Committee person within or outside the institution, until after the first screening. After screening by the Search Committee has begun, all ranked faculty members in the Hiring Unit may review and evaluate applicant files and provide input to the Search Committee; however, non-Search Committee members must not engage in further screening activities. Faculty members who review applicant files assume the same responsibility as Search Committee members of maintaining confidentiality of information contained within the files.

For academic administrator searches other than Department Head searches, only the Search Committee and the administrators in the supervisory chain will review applicant files. The Search Committee will make letters of application and vitas of candidates selected for interviews publicly available.

## Resolution for David Vinyard

WHEREAS, David Vinyard is currently an accelerated master's student in chemistry at Missouri State University;

WHEREAS, David Vinyard graduated Summa Cum Laude with distinction in the Honor's College while majoring in Chemistry and Agriculture with a minor in Music;

WHEREAS, David Vinyard is an exceptional citizen and scholar, as evidenced by his many accomplishments (attachment); including four published peer-reviewed research publications and a provisional patent, his leadership in student organizations, his outreach to the campus community and to local, regional and state organizations;

WHEREAS, David Vinyard's accomplishments and activities have resulted in his being chosen as one of the first Citizen Scholar recipients by the Missouri State Board of Governors;

WHEREAS, David Vinyard was chosen as a Rhodes Scholar finalist, the first student in the history of Missouri State University to be granted such a distinction;

WHEREAS, the Rhodes Scholarship is one of the nation's highest distinctions for those pursuing advanced degrees, and grants the awardees entrance and full tuition to Oxford University in the United Kingdom;

WHEREAS, each institution of higher learning in the United States may nominate one outstanding individual each year for the Rhodes Scholarship. This scholarship is administered by districts, with 16 such districts in the United States, and each district may elect only two Rhodes Scholars;

WHEREAS, David Vinyard was chosen as one of 13-finalists from a field of over 100 candidates to undergo the interview process in the district that includes Missouri;

WHEREAS, such distinctions are a credit to both David and to the academic community at Missouri State University, and reflect his abilities, motivation and the experiences and education he has received;

THEREFORE, BE IT RESOLVED, that the Faculty Senate congratulates and commends David Vinyard on his many accomplishments; and

BE IT FURTHER RESOLVED, that this resolution be presented to David Vinyard, and to the President, Provost, and Board of Governors at Missouri State University.
