Senate Action Conferring Honorary Baccalaureate Degree upon David Trottier

WHEREAS, the honorary baccalaureate is awarded to "recognize the extraordinary achievements of distinguished citizens" especially those with "a strong tie to this community, state, or region"; and

WHEREAS, David Trottier has, as both a private individual and as President of Smitty's supermarkets, a decades long record of generous support for a variety of local institutions working to improve the quality of life in Springfield and the surrounding region; and

WHEREAS, David Trottier has in particular been a strong supporter of local education from Kindergarten though college; and

WHEREAS, David Trottier has over the years, shown a personal commitment to community engagement by acting as a valued mentor to colleagues and employees; and

WHEREAS, the demands of business which significantly increased his ability to help support his contributions to improving life in Springfield and the surrounding area also prevented him from completing a baccalaureate degree;

THEREFORE, BE IT RESOLVED that the Faculty Senate of Missouri State University, meeting on this seventh day of December, 2023, recommend to the university's Board of Governors that the honorary baccalaureate degree be conferred upon David Trottier at the Commencement ceremony in May 2024 in recognition of his long record of civic support and engagement.
