- 2. There are three ad hoc committees for 2018-19:
 - **1-The Ad Hoc Committee on Summer Compensation** Their charge is to examine the formula we use to pay faculty for summer teaching and see if it is possible to come up with fair and flexible alternatives. Cindy MacGregor, the immediate past chair of Faculty senate, is Chairing. The committee contains both faculty and administrators. The Committee hopes to present a report by the end of semester.
 - **2-Committee on Internet Incentive** A joint Provost-Senate committee charged with looking at alternative ways to distribute the money currently allocated for the internet incentive. The university currently charges a premium for internet classes and the instructor currently gets a portion of that. This committee is charged with seeing if they can come up with other equitable ways to distribute that premium among faculty. This committee is co-chaired by Victor Matthews Dean of CHPA and Saibal Mitra, Chair-elect of Faculty Senate. This committee also hopes to have a report back to Faculty Senate by the end of the semester.
 - **3-Ad Hock Advisory Committee of Senate Chairs -** Faculty Senate will continue the advisory committee of past Senate chairs. One of the biggest structural weaknesses of Senate is our patchy institutional memory and this committee is an important corrective to that weakness.
