1.4.1.1. President

The President is the chief executive officer of the University, responsible to the Board of Governors for the administration of all policies adopted by the Board and for the execution of all acts of the Board. The president is served by a variety of officers as indicated in the MSU Organizational Chart. The Provost (~~who also serves as Chancellor for the Mountain Grove Research Campus~~) has responsibilities most directly related to faculty governance, and the organization under the Provost will be detailed in 1.4.1.2. 1.4.1.4. President's Cabinet Administrative Council

The President's Cabinet Administrative Council is chaired by the President. The Cabinet Council includes the Provost, the Vice Presidents, Chief Information Officer, the Chancellor of the West Plains campus, the Athletic Director, the Chief of Staff, the Internal Auditor, the Secretary to the Board of Governors, the Director of Athletics, one college Dean, and the General Counsel, and other administrators may be added at the sole discretion of the President~~Vice President Legal Affairs & Compliance~~. When appropriate to the agenda for a particular meeting, others may be invited as guests. The President's Cabinet makes University-wide decisions for the University, subject to ultimate approval by the Board of Governors~~The Administrative Council discusses items of University-wide issues~~.

1.4.1.4. President's Cabinet

The President's Cabinet is chaired by the President. The Cabinet includes the Provost, the Vice Presidents, the Chancellor of the West Plains campus, the Chief of Staff, the Internal Auditor, the Secretary to the Board of Governors, the Director of Athletics, the General Counsel, and other administrators may be added at the sole discretion of the President. When appropriate to the agenda for a particular meeting, others may be invited as guests. The President's Cabinet makes University-wide decisions for the University, subject to ultimate approval by the Board of Governors.

1.4.5. University Committee Structure

Several committees are appointed by the members of the **President's Cabinet Administrative Council**, the purpose of which is to assist in the ongoing administrative work of the institution. Such committees perform a wide variety of tasks; for example, ensuring conformity with legal requirements for the disposal of toxic wastes, planning the academic calendar, and planning lectures and programs in the performing arts for the campus community. Faculty members routinely serve on such committees.

1.4.5. University Committee Structure

11.5. Administrative Leave

All academic Department Heads and School Directors, all academic Deans, and the faculty members of the President's Cabinet are eligible to apply for administrative leave. Applications must be made through the Office of the Provost prior to November 1 of the year preceding the beginning of the period for which the leave is requested.
