APPROVAL OF MINUTES

The January 2011 minutes were approved as distributed.

REPORT FROM THE TASK FORCE ON GENERAL EDUCATION

Dr. Etta Madden, Chair, presented the report. The <u>Task Force on General Education</u> has a link available on the Provost website, which lists the committee's charge and work phases, committee membership, and meeting minutes.

REPORT FROM RULES COMMITTEE

Secretary Hail, substituting for Rules Committee Chair Dr. MacGregor, presented three charges and committee recommendations. The recommendations will be voted on by the Faculty Senate in the March meeting.

Charge 1:

Examine every usage of the word "action," or the phrase "senate action," in the Constitution and Bylaws to determine whether it refers to an Action as defined in ART I SEC 6.A, and if so, change it to "Action" or "Senate Action." Also consider replacing the word "action" used in a generic sense with a different term, so as to minimize confusion.

The entire Constitution and Bylaws of the Faculty was searched for every occurrence of the word "action" or "actions." This process identified 88 lines of text that required review. If the use of the word "action" was deemed appropriate then no change is recommended. For the remaining instances, the recommended changes can be summarized as:

- Limiting the use of the word "action" as much as possible, except where no other word choice would provide sufficient clarity, unless the word was being used to refer to an Action of Faculty Senate or one of the Councils. Alternate words for "action" are recommended, including words such as "duties," "consideration," or "disposition."
- If the word "action" was referring to a Faculty Senate Action, a College Council Action, or a Graduate Council Action, then capitalization is recommended.
- In some places the wording was unclear so improved language is recommended.

Charge 3:

Examine whether a ranked faculty member in Missouri State University Libraries, who also serves as a "department head" of a service area, can serve as a voting Senator, Rank Representative, or Faculty Senate Officer.

The Bylaws are clear that if a ranked faculty member is a department head, he/she cannot be a senator; except when there are three or fewer ranked faculty members in the department.

The language considered was "should" such an individual be permitted to serve.

The committee determined that the Faculty Bylaws should be clarified on this issue and provide specific language to address those areas where a department is not an academic area. It should also be consistently used throughout the *Constitution and Bylaws*. Changes are needed to lines 275-276 to say "Heads/Chairs/Directors of **academic** departments/schools are not eligible candidates for the position of Chair-Elect and the Secretary of the Faculty." This process also identified 65additional lines of text that required this change to be consistent. These changes are considered non-substantive by the Rules Committee and therefore do not require a vote of the entire faculty.

Charge 5:

The Graduate Council has requested that the Senate Rules Committee examine whether a Graduate Recruiting Committee should be established as a standing committee of the Graduate Council.

The response is to add this as a fifth standing committee of the Graduate council.

Chair Woodard reminded the Senate we will vote on these three items at the March Senate meeting.
