Senate Resolution 12-11/12

Adopted by Senate on February 9, 2012

Faculty Senate Resolution in Support of Equal Rights for Benefits as State University Employees

Whereas, a sophisticated report was prepared¹ and the University of Missouri Faculty Council unanimously passed a resolution for "access to all of the same rights, privileges, and benefits" for same-sex partners that opposite-sex spouses are currently entitled on February 18, 2011; and

Whereas, several representative bodies and groups have already declared their support for the MU report and resolution²; and

Whereas, in the words of Timothy Hall, Athletic Director of the University of Missouri-Kansas City, who wrote in his letter of support, "An end to discrimination should not need to be pleaded or negotiated;" therefore

Be it resolved, that the Faculty Senate of Missouri State University supports the efforts of the University of Missouri to provide equal rights in benefits for all state university employees.

Appendix to the Resolution in Support of Equal Rights for Benefits as State University Employees

¹ The Missouri Intercampus report showed that "domestic partner benefits (DPB) are rapidly becoming the norm for compensation packages in higher education, as well as the private sector" (p. 1), citing that about 400 institutes of higher education, including all Ivy League and all top 10 Universities in the US. This same report showed that clear majorities of benchmark institutions to the University of Missouri institutions, like benchmarks to Missouri State University, provide benefits to domestic partners and/or other household non-employees.

Furthermore, the Intercampus report cited 1997 and 2005 Hewitt Associates studies that found that the majority of employers (64%) experienced a total financial impact of <1% of total benefits cost of enacting domestic partner benefits. Likewise, a 2000 Hewitt Associates study that found inclusion of domestic partners is not more expensive than inclusion of spouses or other dependents, citing possible reasons as domestic partners are typically younger and healthier and less likely to become pregnant. Additionally, studies from various organizations from 1993, 1995, 1996, 2000, and 2005 showed that typically less than 1%, and always less than 2% on average, of employees directly utilized the benefits, but that multiple candidates for job searches turned down positions within the University of Missouri system due to a lack of domestic partner benefits in recent years and that the broad diversity climate for minorities in general may be affected by a lack of domestic partner benefits.

² The Missouri Students Association Senate supported the resolution with a resolution of its own and in a letter to the System President of the University of Missouri on April 25, 2011, followed by support documents by the University of Missouri Council of Deans, Chancellor Brady Deaton, MU Athletic Directors, Graduate Professional Council, the Missouri Conference of the American Association of University Professors, The Missouri Association of Faculty Senates, and others.
