REPORT FROM FACULTY HANDBOOK REVISION COMMITTEE

Dr. Biagioni reported that the committee reviewed the Missouri State University Creation of Intellectual Property Policy. The new revised policy is more detailed and defined.

Senator Kane moved to refer the adoption of the proposed Intellectual Property Policy to a small committee to investigate the changes and to evaluate this document against standards at other comparable universities and report back to the Faculty Senate in March. Membership is to be appointed by the Faculty Senate Executive Committee.

Internal Faculty Senate Action to Commission FTE and Budget Study

Whereas, during the past several years, the Missouri State University (MSU) administration has announced a time of financial crisis, which has resulted in severe cuts to academic budgets, the freezing or elimination of faculty lines, and flat salaries for faculty and staff; and,

Whereas, there is a general perception among faculty that administrative units (e.g., Provost's office, Administrative Services, etc.) that generate little or no revenue have increased both their budgets and personnel in recent years at the expense of academic departments; and,

Whereas, faculty in academic departments generate the majority of the revenue for MSU in the form of student credit hour production (SCH), grants and contracts; and,

Whereas, faculty members are concerned with protecting academic resources most important to student learning: such as the hiring and retaining highly productive ranked faculty, procuring and maintaining current and effective technology in the classroom, and prioritizing academic expenditures that optimize student learning; and,

Whereas, policy decisions that divert larger proportions of revenue to functions that do not directly impact student learning, that do not strengthen the faculty/student interaction, and that do not result in increased scholarship (i.e., research) opportunities for faculty and students are of concern; and,

Whereas, President Cofer has indicated publically on numerous occasions that he wishes an open and transparent budget process; and,

Whereas, a report prepared by the S(MSU) Chapter of American Association of University Professors (AAUP) indicated that from 1993 to 2004; and,

- The growth in ranked faculty positions in instructional areas was 5.5%, far less than the overall increases in total University Full Time Equivalent Positions (FTEs) of more than 33%.
- The salary budget grew by almost 30 million but only 8.6 million (28.7%) of the growth was budgeted for ranked faculty.
- The proportion of University FTEs and budget allocated to instruction decreased from 52.6% to 44.9%.
- Relative to instruction, both FTEs and budgets grew by more than 100% for all Deans' offices. These offices added nearly 34 positions (+177%) and received a budget increase of 1.55 million (+189%).
- From the period covering from 1993 to 2004, the increase of budget allocated to Instruction (41.8%) was lower in proportion than the increases allocated to academic support (109%), student services (59%), institutional support (92%), operations and maintenance (78%), continuing education (290%), athletics (73%), residence life (85%), transit (236%), Taylor Health services (90%), broadcast services (518%)

Therefore, Be It Resolved, that the Faculty Senate Executive Committee charge the Budget and Priorities Committee to prepare a study similar to that prepared by the AAUP but covering the years 2004 – 2010, and using similar methodology, so that valid comparisons can be made;

Be It Further Resolved, that this report be presented to the Faculty Senate no later than the April session, 2011;

Be It Further Resolved, that a similar report be prepared every five years by the Budget and Priorities Committee for presentation to the Faculty Senate;

Be It Further Resolved, that the Rules Committee of the Faculty Senate be charged with incorporating the charge to prepare this report in five year intervals into the *Faculty Bylaws*.
