- 2. The Nominating committee, in keeping with Robert's Rules, only makes one nomination for each position. However, as the Bylaws notes, "Since the Senate benefits from having a strong and diverse slate of candidates, it is desirable that at least one nomination for each office come from the floor so that the candidates nominated by the Nominating Committee do not run unopposed." A nomination may be made by any Senator, with an appropriate second, in writing, to the Secretary of the Faculty no later than April 1. The nominated person must agree to run, and must submit a statement of purpose as outlined in the Bylaws no later than April 3.
 - Eligibility for Chair-Elect and Secretary of the Faculty is open to anyone who "(1) by the time they assume office they will have completed at least one year of service (may or may not be continuous) in the Faculty Senate as a voting member during the previous six academic years, and (2) they are tenured before the September session of their term." Copies of previous Senate rosters can be made available for those who are interested.
- 3. The Faculty Morale Survey administered by the Faculty Concerns committee will go live for responses on Tuesday, January 22 at 8:00, and will remain active until 5:00 pm on Friday, February 1. The survey is anonymous, and only members of the Faculty Concerns survey subcommittee will have access to raw data. No quantitative data will be released that could identify individual faculty members. However, faculty should use caution so that any narrative responses or comments they write do not inadvertently include identifying information. Also, though we are constantly updating our contact lists, it is possible that a faculty member will not receive the reminder email, so please make sure your constituents are aware of the survey.
- 4. As has been announced elsewhere, Governor Nixon recently appointed two new members to the Board of Governors: Carrie Carroll represents the Third district, and replaces John Winston; Joe Carmichael represents the Seventh district, and replaces Elizabeth Bradbury.

REPORT FROM STUDENT GOVERNMENT ASSOCIATION

Ms. Brittany Donnellan presented a Syllabi Database report to the Faculty Senate, for their feedback, outlining reasons to create a central online repository for syllabi. Ms. Donnellan indicated that (1) individual faculty participation in any database would be voluntary, (2) it was understood that a class syllabus in the repository during the early registration period may not be the syllabus eventually used for the class. The major items in each syllabus that were of interest to students were plus/minus grading, teaching style, and course structure. The Senate discussed and offered their feedback. There was no specific proposal or vote.

VOTING ON PROPOSED AMENDMENTS TO THE BYLAWS OF THE FACULTY SENATE
