## REPORT FROM RULES COMMITTEE

Terrel Gallaway, chair, presented the report.

Four of the charges required no change. One change was non-substantive.

This is a non-substantive change:

Charge #1

The term "Faculty Senate Action" is used in the Constitution (ART III, line 37) but is defined in the Bylaws.

Charge #2: No vote needed at this time.

Charge #3: EPPC Membership. A change is suggested in the Bylaws. Largely deleting language about EPP--a non-Senate committee. Senate will vote on this in April.

Charge #4: Classified distinctions in staff. Recommended change in language in the Bylaws. Senate will vote on this in April.

Charge #5: Recommended change to improve the judicial review language in the Bylaws. Senate will vote on this in April.

Charge #6: CGEIP - no recommended change.

Charge #7: Creating a glossary of terms for the Bylaws - it has been created - but it is an internal thing for the committee and it is informal and requires no change to Bylaws.

Charge #8: Representation of instructors and senior instructors in Faculty Senate. This will not be a change this year however as it is researched more.

Carol Miller subbing for Senator Philpot made a motion to revise: the faculty member may reasonably be deemed to have abandoned his or her job duties "as determined by the Provost in consultation with other appropriate administrators." The motion to revise passed.

Ralph Shain made a motion to change "or" to "and" in the sentence: "classes, department meetings AND other required activities" Motion to call the question passed.

The motion to revise failed.

Senator Finch made a motion to delete department meetings and change "activities" to "responsibilities" "classes, or other required responsibilities."

The motion to revise passed.

## 14.5.2. Dismissal for Job Abandonment

The President of the University may initiate formal dismissal proceedings, under this section in situations where, without administrative approval, a faculty member has engaged in a pattern of behavior by failing to perform his or her University duties by being absent from University classes, department meetings or other required activities responsibilities to the extent that the faculty member may reasonably be deemed to have abandoned his or her job duties as determined by the Provost in consultation with other appropriate administrators. Such proceedings will begin by informing the faculty member that the University considers the faculty member in abandonment of his or her job duties, and that the faculty member will be dismissed as of a date specified in the written communication, but in no case less than ten calendar days from the date of delivery of the communication. The faculty member will also be notified by the President that he or she may file a formal grievance within 5 business days from the date of the delivery of the communication. If a grievance is filed, it will follow the APGP process, and the faculty member will continue to receive his or her full salary and employee benefits during the conduct of the APGP process. If no grievance is filed, the dismissal will take effect as indicated in the written communication specified above. For purposes of clarity, termination under this section shall be limited to those situations where a faculty member has not been physically present to perform his or her duties for the University, and this absence is unplanned, not excused, and disruptive to the University. Scheduled absences, or arranged hiatus from University duties will not rise to the level of dismissal under this section.

Pearman also reviewed a change in the Glossary for Senior Instructor.
