The amendment passed.

Senator Ridinger moved to amend the form by adding:

"What was the date that this new course was approved by departmental or program faculty." The amendment passed.

Senator Buckner moved to strike plus/minus grading policy in the following section on the new course form: General Course Description (include any Pass/Not Pass grading restrictions, +/- grading policy, repeatable limits, limitation on course applicability, UG/GR parallel course, etc.)
