- 1. Missouri Association of Faculty Senates' meeting in Jefferson City addressed possible tax shifts, performancebased funding for higher education; completion time for degree programs.

- 3. In response to last year's Senate Action, the administration has agreed to increase the compensation for GEP and UHC using a tier system based on rank. Staff and instructors would get \$2200, Assistants would get \$2500, Associates \$2800 and Full Professors would get \$3200.
