## 2026-2027 No Parental Data on FAFSA

Dear Student,

The Office of Student Financial Aid has received your 2026-2027 Free Application for Federal Student Aid (FAFSA), which was submitted without parental information, even though you are considered a dependent student. Parental information is required for all dependent students under federal law.

While students whose parents refuse to support them are not automatically independent, dependent students without parent data on their FAFSA may still receive *unsubsidized* Stafford loans. However, these students are not eligible for any other federal or state aid. To be eligible for an unsubsidized loan, documentation must be submitted to the financial aid office confirming that:

- (1) The student's parent(s) refuse to provide information for the student's FAFSA; and
- (2) The student's parents do not and will not provide any financial support to the student during the school year.

<u>You must document your circumstances</u> using the guidance on the following page. The Financial Aid Administrator (FAA) has final authority to decide whether you must provide parental information on your FAFSA or not. After reviewing your application carefully, the FAA will determine if your circumstance allows you to proceed without providing parental data. Your FAA's decision is final and cannot be appealed to Federal Student Aid.

Please note that failure to supply supporting documentation will result in an automatic denial of your request for no parental data provision.
