The Committee reviewed the Higher Learning Commission Federal Compliance Program procedural packet.

Committee members who attended the HLC Annual Conference in Chicago reported on the sessions that they attended. They learned about best practices, the needs of next generation faculty, communication needs during crisis, and quality improvement and ongoing continuous assessment with technologies that allow feedback in real time. The National Survey of Student Engagement has changed and includes new benchmarks.

The presentation "Program Review: Policy, Review Cycle and Assessment of the Process – Lessons Learned" by Tammy, Frank and Bill Cheek had over 200 in attendance. There is a great deal of interest in program review and it is something that MSU will continue.

Tammy provided information that she received about the comprehensive visit in 2015. The visit will be 1½ days. The HLC assurance online system will be locked down approximately four weeks prior to the team's arrival when the HLC team will review materials. The team's focus will be on missing items and things that MSU is doing well. Every criterion will be labeled in one of three ways: Met, Met with Concern, Not Met. Tammy received sample evidence by criterion that peer reviewers expect to see and sample red flags by criterion. MSU is on course with preparation for the visit.
