

# Information Technology Council Meeting

## Minutes

Chair Jeff Coiner, CIO called the session to order at 3:32 pm and a quorum was present.

2. Review & Vote on SCUF Proposals Greg Rainwater & Kevin Piercy

We decided to cancel the second meeting in March, therefore the council will review and vote on the SCUF Proposals today.

Mr. Rainwater shared the [SCUF Revenue History](#) handout. SCUF was advised by Financial Services for 2024 to decrease by 2%. Hopefully with student enrollment, overtime we will build back up. The revenue increase helped, but we still have an absence of funds.

Mr. Piercy presented four handouts for the council. The first handout, [FY 2024 SCUF Proposal Overview](#) shows four items in red; these items are new proposals. LMS and central software went up, and we had an increase in central computers. As always, planning for the life cycle spans on the processors. SCUF Central Networking held flat and we try for this centrally. SCUF Central Printing has been cut in half, which is 65,000. The SCUF Central Assistive Technology down 5,000 from last year. The SCUF Central Funds are downward by 18,000. Personnel down 86,000, we are looking at a different demand since the pandemic. Department software varies year by year, with a slight increase for 2024. The computer labs had a decrease of 65,000 as well. Overall, all the proposals for this year are 156,000 less than last year.

We have [FY 2024 SCUF Personnel Costs](#) totaling \$ 666,220.00, along with the [FY 2024 SCUF Central funds](#) totaling \$ 1,355,995.00. The [FY 2024 SCUF Funding Recommendation](#) grand total is \$ 2,030,865.00, with a projected revenue of \$1,919,819 for this year. Unfortunately, we will have a shortage gap of \$ 111,046.

**ACTION RECOMMENDED - Approval of SCUF Proposals**

Jeff Coiner voiced amending, to add the Student Employee Wages for Access Technology Center; to add the 11,880 for approval; along with the other SCUF Proposals.
