Utah Tech University is an open, inclusive, comprehensive polytechnic institution. Utah Tech has six academic colleges including: Business, Education, Health Sciences, Science Engineering & Technology, Humanities and Social Sciences, and the Arts.

**University Achievements:**

***Academic Program Development & Institutional Effectiveness:***

- Oversaw the Utah Tech COVID-19 Crisis Leadership Team. Welcomed a 7% fall and 4.4% spring enrollment increase with no major budget cuts/layoffs during the pandemic.
- Successfully oversaw the Northwest Commission on Colleges and Universities accreditation reaffirmation with a 10-year award (Fall 2020).
- Welcomed the addition of 259 academic programs from 2015-2023 (1 Clinical Doctorate, 6 master's, 59 baccalaureate, 21 associates, 57 certificates, 70 emphases, and 45 minors) and launched Utah Tech University online.
