# Distance Education Handbook

This handbook contains the guidelines and procedures that guide the academic community at Missouri State University in the maintenance of quality standards and best practices in online and distance teaching and learning. This handbook should be considered a supplemental resource to existing university policies found in the Missouri State Policy Library at <https://www.missouristate.edu/policy/>.

Missouri State University is committed to increasing the alternative pathways for degree completion. Missouri State distance delivered courses are held to the same high standards for student outcomes as traditionally delivered courses.

## Distance Education Committee (DEC)

The Distance Education Committee is charged with reviewing, creating, and recommending direction and policy for the Provost's consideration for all alternative forms of teaching, which include such modalities as IVID, online, blended, and online video courses. The committee assists the Provost in coordinating and communicating these policies to the university community.

The Distance Education Committee consists of Missouri State faculty members appointed to the committee by College Deans and representatives appointed by the Provost from the Office of the Provost, Information Services, Faculty Center for Teaching and Learning (FCTL), Missouri State Online, and Missouri State Outreach. The representatives appointed by the Provost are considered standing committee members.

Faculty Representatives appointed to the Distance Education Committee serve for a three-year term. Faculty committee members may serve two successive three-year terms, but then they will be ineligible for reappointment for a minimum of three years. The service terms of Faculty Representatives are staggered. The committee has faculty representation from each of the colleges and a faculty member from the West Plains Campus. ## Alternative Pathways Definitions

- **Online:** programs which offer students the opportunity to obtain a degree completely online in an asynchronous format, offering a variety of undergraduate and graduate programs. Visit Missouri State Online for more information: <https://outreach.missouristate.edu/online>
- **Web Conferencing (also known as CNCT): synchronous** courses in which students and instructors meet via the cloud through web conferencing technology such as Zoom. The instructor may either be in a classroom space, or on a personal device. Participants are primarily joining remotely from personal devices. This type of course involves either only one classroom or no classroom space.
- **Blended:** courses that integrate online and traditional face-to-face class activities in a planned, pedagogically valuable manner; seated component will constitute 40%-60% of course instructional time. This must be specified in the course description.
- **Off-Campus** (also known as IVID): programs that utilize BearNet, a two-way audio/video connection offering live communication between students and teachers at multiple locations. - **Online Video Courses** (previously iCourses): courses that allow students to watch video-recorded course lectures to study whenever they want, wherever they want. Courses are professionally

## **Academic Programs: Online Degrees and Certificates**

Missouri State University currently offers more than 90 graduate and undergraduate degrees, minors, and certificates online. Online credit hours offered at Missouri State continue to expand to meet the needs of our students. Distance education is a contributing factor in the University's plan for future growth. Emphasis is placed upon developing faculty skills in the pedagogy of online teaching and learning. ## **State Authorization and Reciprocity Agreement (SARA)**

MSU membership in SARA provides a reciprocal process for offering distance education opportunities for students outside Missouri and across the United States. Colleges or universities in a SARA state only need their home state authorization to offer distance education to any other SARA member state.

Currently, there are 49 SARA member states. SARA covers online degree programs and clinical experiences associated with online degrees. SARA institutions agree to follow best practices for postsecondary distance education as adopted by the Council of Regional Accrediting Commissions (C- RAC). Missouri State Online provides a web page designating states where MSU is authorized to offer courses for students at a distance. This website is consistently updated to reflect current SARA membership. Non-Missouri students should report complaints through the SARA portal only after exhausting university procedures.

## **Developing Distance Courses**

Distance-delivered courses are considered and initiated by individual departments and are taught by core faculty. Different types of distance courses are designed to serve different needs. For instance, off-campus courses help connect cohorts of students at satellite campuses, while Online Video Courses can replicate large lecture courses at a distance. Instructors who would like to explore different distance education delivery types should contact Missouri State Outreach for more information.

When a department determines that a program will be delivered fully online, provost funding is available for course development. More information regarding this process can be found at

## **Faculty Development Resources**

## Course Development

The Faculty Center for Teaching and Learning (FCTL) assists faculty with course development through week-long boot camps and individualized self-paced schedules. The course development program is designed to assist faculty throughout the development process with the use of effective pedagogy and instructional design. ## Blackboard Training Videos

## Certified Distance Educator Award

The Certified Distance Educator award was established in 2015 to encourage continued professional development in distance education, provide recognition of continued growth in distance education, and foster instructional innovation. ## Assessment in Distance Education

All faculty are required to specify any proctored events clearly in the syllabus. Any proctored event that may require additional fees must be stated in the course listing at the time of student registration.

It is not appropriate to require students from outside the region to travel to Missouri State campus locations for course exams.

## Respondus LockDown Browser

The university makes the Respondus LockDown browser available for use in any course without charge to the student. This tool works with the Blackboard LMS to prevent students from printing or copying exam materials, navigating to other URLs, or accessing other applications during an exam. Respondus LockDown is available for both Windows and Mac systems, making it a viable tool for academic integrity assurance. This product can be used in conjunction with live proctoring at the Testing Center or other locations.

## Respondus LockDown Browser and Monitor

Respondus LockDown Browser has an optional Monitor component that can record students taking an exam by using their personal computer's webcam and microphone. This software is available without charge to the student. The recording of the student is available for instructors to review, and the program automatically flags

potential integrity concerns (e.g., students leaving the computer, additional individuals entering, and students looking away). Instructors that use this tool for proctored testing should give students the opportunity to practice with mock tests prior to actual exams.

This product cannot be used in conjunction with live proctoring at Meyer Library Testing Center. It duplicates the live proctoring process, and the setup requires a microphone and webcam check which are disruptive to other students. Instructors can set up their exams to offer students a choice between a live proctored environment and the Respondus LockDown Monitor recording tool. ### **Online Test Proctoring Products**

Some instructors or programs may wish to utilize third party distance proctoring tools beyond Respondus LockDown Browser and Monitor. Missouri State University follows federal requirements regarding these systems: any additional fees to the student must be stated clearly in the course listing so that all costs associated with the course can be calculated at the time of registration. Please note, these third-party products cannot be accommodated at the Meyer Library Testing Center.

### **Meyer Library Testing Center**

The Testing Center inside Meyer Library is available to use for proctoring exams. Faculty must complete a form to schedule their proctored exam(s) at the start of the semester. Students are required to make an appointment for all exams. Learn more at <https://www.missouristate.edu/TestingCenter>. ### **Missouri State Off-Campus Test Proctoring**

Students located near a Missouri State satellite campus may be allowed to access those facilities for proctored exams at no cost. Updated information regarding available campuses and contacts can be found at <https://www.missouristate.edu/TestingCenter/off-campus-proctoring.htm>.

### **Out of Region Test Proctoring**

Students outside the Missouri State region can also make arrangements for proctored exams, subject to approval of the proctor and location by the instructor. This process should be started early in the semester so that all paperwork can be completed prior to the first proctored exam. ## **Course Evaluations**

The DEC developed a survey instrument used across all online courses to gauge student perception of their learning experience. Missouri State Online, in conjunction with MSU's Colleges, utilizes the Watermark Course Evaluations & Surveys platform with Blackboard integration to deliver course evaluations to students securely and efficiently. The data is collected and distributed to faculty, department heads, and deans and used as part of the faculty evaluation process.

Evaluations for online courses will typically begin the day after the last day to withdraw from the course and will continue until finals begin.

With the addition of survey notification functionality in Blackboard (via a pop-up box reminder), student

responses for online evaluations notably increased. While this is a significant improvement, it is essential that we continue to encourage students to complete course evaluations and stress the importance of the online course surveys university wide. To this end, departments and faculty are encouraged to remind students to complete the surveys, emphasize that evaluation responses are anonymous, and stress the importance of the survey results as an evaluation tool.
