

## 2021 – 2022 Program Report

### Trainings, Presentations, and Programs

**SOAR Parent Presentations** (June 7 – July 28, August 19, 2021, January 12 –13, 2022, June 10, 2022) –Assistant Dean of Students and Director of Student Conduct, Dr. Andrea Weber, and Assistant Director of Student Conduct, Gabby Catlin, in collaboration with representatives from the Springfield Police Department and Missouri State University’s Office of University Safety facilitated brief presentations to parents three times a week on policies, safety and behavioral expectations for prospective students.

**Missouri State Family e-newsletter – Bear Notes** (July 2021) - Assistant Director of Student Conduct, Gabby Catlin wrote an [article](#) to be included in the newsletter for parents of new and returning students about important conversations to engage in between parents/guardians and their students. Sharing resources such as the Code of Student Rights and Responsibilities and providing questions that encourage dialogue about alcohol, drugs, consent, and safety topics.

**Hall Director Training** (August 5, 2021, January 11, 2022) – Assistant Dean of Students and Director of Student Conduct, Dr. Andrea Weber and Assistant Director of Student Conduct, Gabby Catlin, facilitated two trainings for hall staff on adjudicating conduct cases and use of the conduct database, Maxient.

**Resource Fair:** (August 16, 2021) - Graduate Assistant for Student Conduct, Chase Stockton, and Graduate Assistant for the Dean of Students, Malachi Stroud facilitated a table at the Resource Fair held for Resident Assistants and the Executive Board of the Residence Hall Association to explain the operations of the Office of Student Conduct and the Dean of Students office and program collaborations possible with the offices.

**The Great Bear Hunt** (August 16-27, 2021) - The Office of Student Conduct participated in First Week programming to encourage students to become familiar with campus by hiding mini bears around campus with tickets students can trade in for prizes in various offices. In addition, students had the opportunity to fill out an educational activity with information about each of the partnering offices for the chance to be entered into a drawing for a larger prize.

**Welcome Social for the Bears for a Just Community** (August 20, 2021) - Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton and other staff and faculty partners were invited to an opening social for the Bears for a Just Community (BJC). This community, a floor of students in Shannon House are part of the Living Learning Community program for Housing and Residence life. BJC is specifically comprised of students who are interested in discussing and serving communities based on social justice and diversity.

**Belong B-Q** (August 22, 2021) - Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton facilitated a table at Belong B-Q, which is Multicultural Services major event during Welcome Weekend. A combination cookout, information fair, and performance, the Belong-B-Q showcases the wide range of diverse student

organizations and resources here at Missouri State University. The Office of Student Conduct used this opportunity to engage with students and share information about our office.

**What Would Boomer Do? - Social Media Campaign** (Fall 2021) - Assistant Director of Student Conduct, Gabby Catlin and Graduate Assistant for Student Conduct, Chase Stockton, developed scenarios surrounding the Code of Student Rights and Responsibilities and the Conduct process. These were posted weekly on Instagram and Twitter for students to submit answers about what Boomer would do in those situations.

**House Calls** (September 1, 2021) - Assistant Director of Student Conduct, Gabby Catlin participated in House Calls sponsored through Residence Life, Housing and Dining Services. House Calls is an interactive opportunity for the staff to meet residents on a one-to-one basis by visiting their residence hall rooms.

**Missouri State Family e-newsletter - Bear Notes** (September 2021) - Graduate Assistant for Student Conduct, Chase Stockton wrote an [article](#) for the family newsletter that goes to parents of new and returning students. The article included information about the office, process, and staff members.

**Office of Student Conduct Tabling** (September 10, 17, 30, 2021; October 14, 2021) - Graduate Assistant for Student Conduct, Chase Stockton, held a variety of tabling sessions to inform students and university community members about the Office of Student Conduct.

**Hazing Prevention Week** (September 20 – 24, 2021) - Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton, developed a series of social media informational posts and a [blog posting](#) for Hazing Prevention Week. These included facts about hazing, what hazing is, and the dangers of hazing.

**Delta Sigma Pi Presentation** (September 21, 2021) - Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton, presented to Delta Sigma Phi about the dangers of alcohol and drug misuse, as well as important university policies.

**Blog Posting/Bear Notes** (October 2021)- Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton, created a blog post and Bear Notes entitled “[Learn the Dangers of Alcohol Misuse](#)” for students and families. **MoState Family Feud** (October 27, 2021) - Graduate Assistant for Student Conduct, Chase Stockton, along with partners Academic Integrity, Counseling Center, Green Dot, and the Office of Student Engagement, developed a family feud style game for student organizations to learn more about university policies, campus resources, and interact with other student organizations.

**Trick or Trivia** (October 2021) - Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton, developed a series of Trick or Trivia questions about the Code of Student Rights and Responsibilities and the conduct process for students to answer. The questions were posted weekly to Instagram stories throughout the month of October.

**Blog Posting/Bear Notes** (November 2021) - Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton, developed a blog posting and Bear Notes article entitled “[Addressing Family Conflict Over Break](#)”. This article included information about how to handle family conflict over the coming university break, including tips and campus resources.

**Expressive Activity Blog** (November 2021)- Assistant Director of Student Conduct, Gabby Catlin, and Graduate Assistant for Student Conduct, Chase Stockton, developed a blog posting entitled “[Free Speech and Expressive Activity at Missouri State](#)”. This blog included information about free speech, the Expressive Activity Policy, and how to engage with topics students may disagree with.

This posting included information about the upcoming finals week, campus resources, and winter break move out for residence halls.

**Fraternity and Sorority Life Leadership Retreat** (January 14, 2022) – Assistant Director of Student Conduct, Gabby Catlin presented to fraternity and sorority chapter presidents and Interfraternity Council, Panhellenic Association, and National Pan-Hellenic Association boards about the conduct process, policies, and office information.

**Breaking BEARriers Presentation** (March 2, 2022) - Assistant Director of Student Conduct, Gabby Catlin presented about Missouri State’s policy on Medical Marijuana and answered questions from students.

**Emerging Leaders Presentation** (March 9, 2022) - Assistant Director of Student Conduct, Gabby Catlin presented to first- and second-year students in the Emerging Leaders program about functional communication, teamwork, and motivation.

**Chief Justice Training** (March 24, 2022) - Assistant Director of Student Conduct, Gabby Catlin, facilitated a training on the conduct process and the overlap with the Fraternity and Sorority Life conduct process to the Interfraternity Council (IFC) and Panhellenic Association (PHA) Chief Justices and delegates.

**SOAR Leader Presentation** (May 24, 2022) - Assistant Director of Student Conduct, Gabby Catlin, facilitated training to SOAR leaders on the Office of Student Conduct, Code of Student Rights and Responsibilities, and the conduct process.
