Trainings, Presentations, and Programs

SOAR Parent Presentations (May 31 – July 25, August 15, 2024, January 9, 2025) – Director of Student Conduct, Gabby Catlin, and Graduate Assistant Haley Hawkins in collaboration with representatives from the Springfield Police Department and Missouri State University's Office of University Safety facilitated brief presentations to parents twice a week on policies, safety and behavioral expectations for incoming first year students.

Resource Fair: (August 13, 2024) - Director of Student Conduct, Gabby Catlin, Assistant Director, Tony Vienhage, Student Conduct Graduate Assistant, Haley Hawkins, and Dean of Students Office Graduate Assistant, Tyrah Brackebusch, facilitated a table at the Resource Fair held for Resident Assistants and the Executive Board of the Residence Hall Association to explain the operations of the Office of Student Conduct and the Dean of Students office and program collaborations possible with the offices.
